## Section 19 Covenants and Restrictions

Paragraph 19.11 Has been amended as follows:

The paragraph shall be deleted. The following paragraphs shall be added: No animals or pets of any kind being raised, bred or kept in any Living Area, the Limited Common Area, or any portion of the Common area by Owner or any other person or visitor to the property. In the event an Owner request an exception to this restriction they may do so by petitioning the Board of Directors to allow said exception.

If granted the Owner must register the animal or pet with the Association President or his/her designate. Registering the animal or pet includes but is not limited to: Unit number, Unit Owner, Animal Owner name, Animal Breed, general description, copy of papers where applicable, and one time non refundable registration fee of \$ 50.00. Failure to register will result in removal of animal from property by the Board of Directors without prior notice to owner. Property owner is responsible and liable for any external damage to property or person due to animal or pet and removal of all pet waste. Dogs must be leashed at all times in the Common Areas. Board of Directors may ask animal or pet to be removed from Northlane Condominiums at any point, at such time reasonable cause for said action will be disclosed.
