- 1.     - (a) If Defendant shall depart the jurisdiction of the court without the written consent of the court and ROCHE SURETY & CASUALTY COMPANY, INC., or its Agent.
    - (b) If Defendant shall move from one address to another without notifying ROCHE SURETY & CASUALTY COMPANY, INC., or its Agent in writing prior to said move.
    - (c) If Defendant shall commit any act which shall constitute reasonable evidence of Defendant's intention to cause a forfeiture of said bond.
    - (d) If Defendant is arrested and incarcerated for any offense other than a minor traffic violation.
