


MESSAGE FROM THE CHIEF EXECUTIVE OFFICER

PRIORITY 1: System Impact Focus

Goal Statement:

We will advance an integrated system of quality home and community care services that enable people to live well at home and in the community.



- 1.1 Develop and promote the value proposition for home and community care working seamlessly together within an integrated care delivery system.
- 1.2 Facilitate the development of a data strategy for the sector and contribute to provincial digital health initiatives.
- 1.3 Support the sector in its development of programs and services that advance integrated care, such as defining core services, care models and performance measures related to home and community care.
- 1.4 Support our members' participation in Ontario Health Teams (OHTs) and contribute to future system design by OHTs and Ontario Health, including funding and governance models, on behalf of the home and community care sector.



PRIORITY 2: Advocacy Focus

Goal Statement:

We will be the leading voice on home and community care in Ontario and a trusted partner in shaping the future of Ontario's health and social care system.



- 2.1 Continue to advocate for expansion of publicly funded home and community care to enable people to live well at home.
- 2.2 Maximize partnership with other associations to strengthen our collective voice to build an integrated health and social care system.
- 2.3 Partner and disseminate evidence that articulates the value of health and social care services.
- 2.4 Support the advocacy efforts of our members.
- 2.5 Elevate the voices of clients and families in our advocacy efforts.



PRIORITY 3: Supporting Member Capacity

Goal Statement:

We will help equip our members to deliver improved and more integrated client-centred care.



- 3.1 Offer initiatives that support members to partner, collaborate and integrate in a transformed health and social care system.
- 3.2 Work with members to enhance criteria for membership in OCSA and member capacity to achieve them.
- 3.3 Support sector leadership development.
- 3.4 Continue to seek out and offer members a robust range of benefits and services.



PRIORITY 4: Internal Focus

Goal Statement:

We will continue to build a dynamic and nimble association that drives improvement in health and social care.



- 4.1 Develop and implement a revenue expansion strategy.
- 4.2 Create and implement an HR strategy to attract and retain a skilled and robust talent pool.
- 4.3 Develop an internal capacity plan to identify required bench strength in priority areas to achieve organizational strategies.
- 4.4 Explore options for how OCSA can best support the sector in a post-transformation, highly integrated health and social care system.
- 4.5 Explore back office efficiencies.
