**FY 2019-2020 Audit:** Business Administrator Hoving presented the final draft of the FY 2019 – 2020 audit. The audit which was completed by the accounting firm Selden Fox, Ltd. of Oak Brook IL. Business Administrator Hoving reported that the district remains solid financially. The district reported revenues exceeded expenses by \$313,605.78 in the corporate fund and the net position increased by \$512,099.00. Trustee Taglia moved, seconded by Trustee Clampit to approve the final draft of the FY 2019-2020 Audit as presented. Ayes: Hensley, Taglia, Clampit. Motion carried.
