Reconciliation Report – December 2020: Business Administrator Hoving presented the December Reconciliation report for review and discussion. Trustee Clampit moved, seconded by Trustee Taglia to approve the Reconciliation report for December 2020 as presented. Ayes: Hensley, Taglia, Clampit. Motion carried.

Investment Reccomendations:

Debt Service Fund — Business Administrator Hoving recommended transferring the CD maturing on January 28, 2021 in the amount of \$70,000.00 plus interest to the Debt Service Fund checking account at 5/3 Bank. Low Voltage Switch Gear Pay Application #11: Engineer Mark Halm presented pay estimate #11 for the LVSG/MCC project. The request was in the amount of \$60,796.80. Trustee Clampit moved, seconded by Trustee Taglia to approve the pay application in the amount \$60,796.80 as presented. Ayes: Hensley, Clampit. Motion carried.

Manager's Report – December 2020: Manager Listwan presented his report for the month of December. Trustee Taglia moved, seconded by Trustee Clampit to approve the Manager's Report for December 2020 and place it on file. Ayes: Hensley, Taglia, Clampit. Motion carried.

Raw Sewage Pump Replacement: Manager Listwan presented a proposal from Lai, ltd. to furnish a replacement raw sewage pump in the amount of \$26,500.00. Mr. Listwan stated that currently two of the four raw sewage pumps are out of service being re-built. He would like to purchase a new pump which would bring the total raw sewage pumps at the district to five (5). The fifth pump would be kept on standby for when the other pumps are being serviced. Trustee Clampit moved, seconded by Trustee Taglia to allow Manager Listwan to issue a purchase order for a new raw sewage pump in the amount of \$26,500.00 from Lai, LTD. Ayes Hensley, Taglia, Clampit. Motion carried.

<u>Water Meter Intergovernmental Agreement:</u> The board received an update from staff regarding the Intergovernmental Agreement with the Village of Villa Park for the cost sharing of the water meter reading hardware and software. Mr. Hoving reported that the district is still awaiting a revised draft of the agreement.
