Work included the installation of electrical conduit, windows and masonry work. <u>Manager's Report-April 2020:</u> Manager Listwan presented his report for the month of April. Trustee Clampit moved, seconded by Trustee Taglia to approve the Manager's Report for April 2019 and place it on file. Ayes: Hensley, Taglia, Clampit. Motion carried.

<u>Life Insurance Renewal:</u> Business Administrator Hoving presented the proposal from MetLife to renew the District's life insurance from July 1, 2020 through June 30, 2021. He stated that the carrier is holding rates at their current level and the district budgeted for a 5% increase for FY 2020-2021 and that the district pays \$290.96 per month. Trustee Clampit moved, seconded by Trustee Taglia to authorize the renewal of the life insurance with MetLife. Ayes: Hensley, Taglia, Clampit. Motion Carried.
