

ORDINANCE NO. 535

AN ORDINANCE INCREASING THE USER CHARGES FOR  
THE SALT CREEK SANITARY DISTRICT, VILLA PARK, DUPAGE COUNTY, ILLINOIS

WHEREAS, the Salt Creek Sanitary District has adopted a system of charges for users of the District's sewage treatment works; and

WHEREAS, such charges are to be established annually by ordinance duly enacted; and

WHEREAS, the District's Board of Trustees desires to approve a base user charge rate increase of \$.29 from \$4.21 to \$4.50 by Ordinance; and

WHEREAS, \$.09 of the increase shall be for Corporate and Operating expenses and \$.20 shall be for Debt Service.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE SALT CREEK SANITARY DISTRICT, COUNTY OF DUPAGE, STATE OF ILLINOIS AS FOLLOWS:

Section 1. The Salt Creek Sanitary District base user charge rate shall be \$4.50 per 1000 gallons of water usage, as determined by the appropriate water supplier, for bills issued on or after May 1, 2016.

Section 2. Nine cents (\$.09) of the increase shall be placed into a fund or funds for Corporate and Operating Expenses and twenty cents (\$.20) of the increase shall be placed into a fund or funds for Debt Service to the wastewater treatment plant. The result of this increase shall be that the amount of the base user rate to be placed into a fund or funds for Corporate and Operating Expenses shall be \$2.98 and the amount of the base user rate to be placed in a fund or funds earmarked for Capital Improvements including but not limited to Phases 3, 4 and 5 Debt Service to the wastewater treatment plant shall be \$1.52.




