Capital Improvement Ordinance #530 Trustee Hensley moved, seconded by Trustee Keating to approve Ordinance #530 charging \$4.00 quarterly flat fee for capital improvements. 90% to be transferred to the Districts Improvement Fund and 10% to Replacement Fund. The charge shall apply regardless of wastewater usage billed on a quarterly basis, effective upon the first billing after May 1, 2015. Ayes: Dewyer, Keating, Hensley. Nays: None. Motion carried.
