Quarterly Collections Report Bus. Admin. Seaton presented the 2012, 4<sup>th</sup> quarter collection report, stating that the Districts outstanding delinquent accounts have been reduced to \$14,000.00 in liened properties. This represents the lowest amount recorded since the District began billing in 1979.

Annexation of Property Attorney Kay requested authorization to prepare annexation for the property located at 841 N Princeton Ave. Trustee Dewyer moved, seconded by Vice-President Keating to authorize Attorney Kay to annex 841 N Princeton to the Salt Creek Sanitary District and record with the county recorders office. <u>Tertiary Building Update</u> Engineer Halm presented a quarterly report showing the progress of the Tertiary Building project through the end of January.

Mr. Halm presented to the board a pre-application loan document that would put the District on notice with IEPA for any available funds that would be used for the Ph. 5 – Digester Cover Replacement Project slated for 2015. The deadline for submitting the pre-application is March 31, 2013. Mr. Halm informed the board that be signing the pre-application and submitting it by the deadline does not commit the District to any action. Discussion ensued regarding the project. The board concurred to table the matter until the March board meeting.

Manager's Report/January Manager Listwan presented his report for the month January.

Discussion on high influent solids loading and the impact on pumps and primaries. The possible improvements to the preliminary screening treatment.
