Present: Chairman Dirk Bowles and Commissioners Scott Workman and Boyd Burbank, and Clerk Shauna Geddes.

1. PLEDGE OF ALLEGIANCE

- **2. ADDITIONS TO AGENDA**—Scott made a motion to add Hospital Property to the agenda. The 2nd was made by Boyd and passed unanimously.
- **3. GROLL FAMILY FITNESS** Owner Janene Groll requested her buildings to be assessed as one building and that the valuation be based on the income approach. She also asked for help with her late fees and would like to set up a payment plan. The Treasurer can set up a payment plan
- 4. PRESTON SCHOOL DIST Superintendent Joel Wilson and school board member Jody Shumway met with the Commissioners to discuss the building that will be taking place. The school district will be putting a building on a foundation that is already there. The building will just be a shell with the intention of eventually being turned into a Rec Center.

 Superintendent Wilson also thanked the Road Department for their work in getting the bus routes clear during these past snow storms.
- 5. CONCEALED WEAPONS PERMIT FEES SHERIFF DAVE FRYAR—Sheriff Fryar would like the commissioners to raise the fee for Concealed Weapon Permit. He would like the fee to be comparable with the surrounding counties. This will be turned over to the Prosecutor to draft a resolution. A public hearing will be held next meeting
- **6. TAX DEEDS** –Treasurer Jeanette McKay needs to take 4 tax deeds:

 Scott made a motion to authorize Treasurer Jeanette McKay to take tax deeds on

Jeanette also informed the Commissioners that the property that was taken in a tax deed last year is now ready to be sold. She will give the information to County Attorney Vic Pearson.

7. JARED EGLEY CLASS 1 - This is a 1 lot subdivision in Mink Creek. It is 5 acres with deeded access, a private well and septic system. It has met all the requirements and the Planning & Zoning Commission unanimously approved it. Scott made the motion to accept the Jared Egley Class 1 Subdivision. Boyd seconded the motion. All voted in favor.

8. COUNTY BUSINESS—

Budgets –After looking over the budgets, it was noted that the claims for the health insurance were at 56%.

Negotiation Contract Services – No decision can be made until other bids have been called for and received.

Postage Meter — Scott made the motion to authorize the Treasurer to enter into a contract with Mountainland Business Systems, Inc for a new postage meter. Boyd seconded the motion and the motion was carried unanimously.

Hospital Property – There are currently about 17 parcels that describe the property where the hospital and nursing home sit. Some are titled to the County and some to the Medical Center. For insurance purposes all the property needs to be titled the same. Scott will visit with the Hospital and see what they want to do.

- 9. HEALTH DEPARTMENT / KEVIN BLANCH The quarterly report of the Southeastern Idaho Public Health Department was presented by Kevin Blanch. There have been 3,032 clients served and \$89,051 in WIC money spent in our county during the second quarter. Kevin also said that they were pleased with the remodel of their office and have had many compliments.
- 10. EXECUTIVE SESSION ¶67-2345 (1)(d)—At 10:26 a.m. made the motion to go into executive session to discuss indigency. Boyd seconded the motion. A roll call vote was called with an "Aye" vote from each commissioner. At 10:55 a.m. the executive session ended.
