Present: Chairman Dirk Bowles, Commissioners Scott Workman and Boyd Burbank, County Attorney Vic Pearson, and Deputy Clerk Leiza Povey

- 1. PLEDGE OF ALLEGIANCE
- 2. **APPROVAL OF THE MINUTES** Workman motioned to approve the minutes of February 11th & 25th, 2013. Burbank seconded the motion. All voted in favor.
- 3. **ADDITIONS TO AGENDA** Bowles motioned to add Counseling for County employees. Scott seconded the motion. All voted in favor.
- 4. **APPROVAL TO PAY BILLS** Workman motioned to approve payment of County Bills for February. Burbank seconded the motion. All voted in favor.
 - After discussing concerns about the Fire Station Lease, paragraph #7, Commissioners felt that a meeting was needed to discuss the lease. Workman will talk to Preston City.
- 5. SHERIFF FRYAR JAIL Sheriff Fryar spoke with the County Commissioners concerning the need for a new county jail and addressed concerns voiced to him by county citizens. He stated that felony cases have dropped considerably and the inmate numbers have been average. He also stated that Caribou County has been very cooperative. Commissioner Burbank has been putting together numbers to see if there is a need and if the cost would be something the County can purchase.
 - Sheriff Fryar stated that Kelly Biggs will be the new resource officer at Preston High School and will begin on April 1.
- 6. **FARMER OF THE YEAR** Commissioners presented H&S Dairy, Kyle Knapp with the Farmer of the Year and gave him a plaque.
- 7. PUBLIC HEARING CONCEALED WEAPONS PERMIT FEE Workman motioned to go into the Public Hearing. Burbank seconded the motion. All voted in Favor. Resolution 2013 11 for New Concealed weapons permits to be increased from \$60 to \$75. Renewal would be increased from \$30 to \$50. No public attended the meeting. Workman motioned to approve the resolution. Burbank seconded the motion. All voted in favor.
- 8. **EXECUTIVE SESSION ID 67-2345** Workman motioned to go into executive session at 10:10 am. Burbank seconded the motion. Each voted in favor. Executive session ended at 10:30.
- 9. **TAX FORGIVENESS PARCEL #2292.02** Lindsey Mumford attended the meeting to discuss valuation on her home and that it does not have a basement. Assessor Cundick explained the problem of 7 years and that Mumfords have been overcharged \$1600 for

7 years. Workman motioned to cancel 2nd half of tax amount for 2013 for \$827.90. Burbank seconded the motion. All voted in favor.

- 10. **INDIGENCY** Ruth Rawlings presented Cases #2013-00016 and #2012-00017. Workman made a motion to deny the application. A second was made by Burbank and all voted in favor of the motion.
- 11. **COUNSELING** The Commissioners discussed the benefit of having counseling sessions for County employees. Todd Thomas had presented the idea to Commissioners in the past. This is something they would look at it for the next budget year.

The Board of County Commissioners recessed at 11:25 am until March 14, 2013, when canvass of county elections will be completed.

The Board of County Commissioners reconvened at 9:00 a.m. In attendance were Commissioners Dirk Bowles, Scott Workman, and Boyd Burbank. Also in attendance was Clerk Shauna Geddes.

ADDITIONS TO AGENDA – Scott Workman made a motion to add to the agenda the approval of a Beer License for Preston Golf & Country Club and Warren Wilde. The second was made by Boyd Burbank and passed unanimously.

CANVAS OF VOTES -- The Commissioners met as the Board of Canvassers to certify the results of the election on March 12. Scott Workman made the motion to accept the results of the elections that were held in the West Side and Grace School Districts as presented. Boyd seconded the motion and the vote passed unanimously. The West Side School District held a Supplemental Levy. With 113 votes cast, the levy passed 99 for and 14 against. The Grace School District held a Supplemental Levy and with 80 votes cast; the levy passed 60 for and 20 against.

BEER LICENSE – A motion to approve a beer license for beer to be consumed on premises for the Preston Golf and Country Club was made by Scott. Boyd seconded the motion and all voted in favor.

WARREN WILDE/HOMELAND SECURITY – A letter was given to Warren informing him that the county is no longer able to provide Health Insurance to part-time employees.

Warren shared a copy of the 2012 Homeland Security Grant information. \$23,053.35 total was awarded with \$1688.34 coming from cost share.

Meeting was adjourned at 10:30 a.m. Next meeting will be held March 25, 2013.
