August 12, 2013 9 a.m.

Present: Chairman Dirk Bowles and Commissioners Scott Workman and Boyd Burbank, and Clerk Shauna Geddes.

1. PLEDGE OF ALLEGIANCE

- **2. ADDITIONS TO AGENDA**—Scott made the motion to add Gun Range, Airport Contracts, Juvenile beds, Beer License Executive Session for Personnel to the agenda. All voted in favor after s second from Boyd.
- **3. APPROVAL OF BILLS**—All voted in favor of paying the bills after a motion from Scott and a second from Boyd.
- **4. WINE BY THE DRINK** Shelly Spackman asked that the ordinance permitting wine by the drink be re-addressed. The Commissioners agreed to look at the ordinance again. They will begin the process.
- 5. TOM ROLEY –TRUCKS ON 1400 WEST –Mr Roley lives on 1400 West and says that there are a lot of big trucks who use their compression breaks. His wife is ill and this is disturbing for her. He is requesting that signs be placed restricting the use of Jake breaks. The Commissioners brought up that this is an agricultural area and the county has a Right to Farm Ordnance. They will take it under consideration.
- 6. SPEED LIMIT ON HEBDON ROAD /TROY MOSER —Troy has placed road counters on 1600 South (West) also known as Hebdon Road. He advises that the speed limit for that road be reduced from 35 mph to 25 mph. Boyd made a motion to reduce the road on 1600 South (West) to 25 mph because of dust and traffic. Scott seconded the motion. All voted in favor.
 - The Commissioners would like Troy to put a counter on Rindlisbakers road and will estimate the cost of bringing that road to standards.
- 7. **ALDER MINK RANCH** –The Alder brothers submitted applications to the Planning & Zoning for a Mink Ranch on 800 East (Beckstead Lane) They are submitting two applications because under one application they cannot meet the buffer area requirements for an Animal Confinement Operation of their size. They will have a maximum of 66,000 mink and would like to move the animals there next year. The county attorney will review and the commissioners will vote on the ACO next meeting.
- 8. GUN RANGE Considerable work has been done on the Gun Range. On June 29, Eight people worked for a total of 32 hours and two more worked 20 more hours for a total of 53 hours of improvement. They replaced the steel supports with 24 ground mounted targets. On July 29 86 hours were spent on the Pistol range removing topsoil with rocks and leveled off. They worked on an impact wall and replaced steel structures and installed 14 new targets. The road department also leveled the base and new garbage cans have been placed.

- **9. AIRPORT CONTRACTS**—New Airport Hangar contracts need to be drawn up. Boyd will meet with the Airport board on August 26th to discuss this.
- **JUVENILE BEDS** Seth Scott came from the Dept of Juvenile Corrections to discuss the terms for Franklin County owning 2.5 beds at Juvenile Detention Center in Pocatello. Before 2007 payments to the Center were based on the ownership. After that the charges were based 50% on allocation (ownership) and 50% on what was used.
- **BORDERLINE GRILL -BEER LICENSE--** Boyd made a motion to approve the beer license for Borderline Grill for beer to be consumed on the premises. Scott seconded the motion. The motion was carried unanimously
- **EXECUTIVE SESSION ¶67-2345 (1)(a)**—At 12:10 p.m. Scott made the motion to go into executive session to discuss personnel. Boyd seconded the motion. A roll call vote was called with an "Aye" vote from each commissioner. At 12:35 p.m. the executive session ended.

The meeting was adjourned at 12:40 p.m. The next meeting will be August 26, 2013.
