Present: Chairman Dirk Bowles, Commissioner Boyd Burbank, Commissioner Scott Workman, Attorney Vic Pearson and Clerk Shauna Geddes

1. PLEDGE OF ALLEGIANCE

- **2. APPROVAL OF MINUTES**—Scott made a motion to approve. Dirk second. Motion passed unanimously.
- **3. ADDITIONS TO AGENDA**—Scott made the motion to add Fox Tail Subdivision to agenda. Dirk second and passed unanimously.
- 4. COUNTY HEALTH INSURANCE/ERIC FALK MORETON & CO. Eric has been looking into a County Dental Plan. Regence and Blue Cross would not do a standalone dental plan. DentiMax Plan is not as aggressive in cost effectiveness, but the administration fees will be the same and most of the local dentists are on the plan. Scott made the motion to designate DentiMax as the county dental plan. Boyd seconded the motion which passed unanimously.

5. COUNTY BUSINESS -

Approval of the Bills- A motion to approve the payment of the county bills was made by Scott. All voted in favor after a second from Boyd.

Canvas of Votes – Boyd made the motion to authorize Dirk to sign the canvas of votes for the November 5th Elections. All voted in favor after a second from Scott.

PRT Support Letters—Boyd made a motion to authorize Dirk to sign a letter committing matching funds to Pocatello Regional Transit in the amount of \$8,250.00 (\$6,500 for commuter and \$1,750 for local services). Scott seconded the motion. It passed unanimously. **Outstanding Parking Lot Bills-** Vic and Boyd have been writing letters and visiting the businesses who are behind in their payments. Some have been making payments.

Road Abandonment Proceedings –It is the landowners responsibility to request in writing the closure of a road. After that the Commissioners can proceed. Scott will pass the information along.

Employee Vacation Balances —The County will give any employee until the first of the year to use their vacation time. After that it will be brought down to the maximum allowable carryover. It would be more convenient for the auditors and payroll for the cutoff date to be closer to the end of the budget year.

Beer Licenses— A motion to approve Alcohol permits for the following businesses was made by Scott with a second by Boyd; All voted in favor:

Approve Holiday Schedule —The Commissioners agreed to allow the county offices to close at 1:00 the Wednesday before Thanksgiving.

Access Idaho - Boyd motioned to authorize Dirk to sign the agreement with Access Idaho for landfill to accept credit cards. Carried unanimously after a second from Scott.

- 6. JUVENILE UPDATE/LENNART NIVEGAARD—Lennart shared with the Commissioners the legislative update for 2014. It costs an average of \$213.57 per day to house a juvenile at a Level 4 in the state facility at St Anthony. Franklin County currently has 4 juveniles housed there.
- FOX TAIL SUBDIVISION Kim and Carol Wolfley would like to divide lots in the original Fox Run Subdivision. The Planning & Zoning Commission had denied because of minutes from a 1999 P&Z meeting stating that the lots will not be divided further. They are appealing the P&Z decision based on the fact that other lots nearby are being divided and that the moratorium on Fairview Water has been lifted. Water availability being the main concern in 1999 for not allowing the division of the lots. This item is tabled until John Burg can be reached.
- **8. EXECUTIVE SESSION ¶IC 67-2345 (d)** At 11:55 a.m. Dirk made the motion to go into executive session. There was a second by Boyd and a roll call vote was taken. Each Commissioner voted "Aye". At 12:55 p.m. the executive session ended.
- 9. Indigent Case-

Boyd made motion to deny indigent case #2014-10005. Dirk second. Motion passed unanimous.
