



**FRANKLIN COUNTY COMMISSIONERS**

1. **CANVAS VOTES FOR AUGUST 30, 2016 ELECTION-** Franklin County Commissioners met as a board of Canvassers. They reviewed the results of the August 30, 2016 election for a Plant Facilities Levy for the Grace Joint School District #148. The election was conducted as a mail out precinct. Out of 130 registered voters in the Thatcher Precinct 59 ballots were returned for a 45.38% voter turnout. Out of the 2 voters in Treasureton Precinct, one ballot was returned. There were 44 Yes votes and 16 No Votes. Boyd made the motion to approve the election results for the August 30, 2016 election as presented. Dirk seconded the motion. All voted in favor.
  
2. **FRANKLIN COUNTY EMPLOYEE SUMMER PARTY-** The summer party was well attended and lots of fun. The Road Department and Extension office prepared the food. Prize drawings were organized by the Treasurers Office.


