## AMENDMENT TO BY-LAWS OF SALEM SQUARE OWNERS ASSOCIATION

The Board of Directors shall be elected as provided in the Bylaws, as modified by Section 8 of the Declaration."

Insert: "The management and maintenance of the property and the business, property, and affairs of the Salem Square Owners Association ("association" shall be managed by a Board of Directors consisting of at least seven (7) members, but no greater than nine (9) members, who need not be unit owners. The Board of Directors shall be elected as provided in the By-Laws, as modified by Section 8 of the Declaration."
