

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to <https://americasfavoriteinsurance.com/> and America's Favorite Insurance and Tax and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to America's Favorite Insurance and Tax include <https://americasfavoriteinsurance.com/>, AFI, Insurance and Tax Franchisors, <https://www.insuranceandtaxfranchisors.com/> and <https://www.americasfavoritetax.com/>. The AFI website is a Insurance and Tax Services site. By using the AFI website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, AFI may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

AFI may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender
- Household Income

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

AFI collects and uses your personal information to operate its website(s) and deliver the services you have requested.

AFI may also use your personally identifiable information to inform you of other products or services available from AFI and its affiliates.

Sharing Information with Third Parties

AFI does not sell, rent or lease its customer lists to third parties.

AFI may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. AFI may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to AFI, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by AFI. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the AFI website.

Use of Cookies

The AFI website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server.
