### Assumption of Risk:

1. I, the undersigned, wish to play Paintball/Speedball/Splatmaster/Bubble Soccer/Bungee Trampoline; I recognize and understand that playing Paintball/Speedball/Splatmaster/Bubble Soccer/Bungee Trampoline (hereafter call the "Games") involves certain risks. Those risks include, but are not limited to, the risk of injury resulting from possible malfunction of the equipment used in the games and injuries resulting from but not limited to, tripping or falling over obstacles in "the games" playing fields (s). In addition, I recognize that the exertion of playing the games could result in injury or death.
2. Despite these and other risks, and fully understanding such risks, I wish to play "the Games" and hereby assume the risks of playing said games. I hereby hold harmless the "Sponsors" and indemnify them against any or all claims, actions suits, procedures, cost expenses (including attorney's fees and expenses), damages and liabilities arising out of, connected with, or resulting from playing "the Games", including without limitation, those resulting from the manufacture, selection delivery, possession, use or operation of such equipment. ### RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT
