### **Employee Referral Bonus**

Quality Care Services, Inc is committed to recruiting and retaining the best-suited individuals. Employees are encouraged to refer qualified candidates for positions at Quality Care Service,

#### **Eligibility**

- 1. There does not need to be an open position at the time of the referral.
- 2. A referred candidate hired into any ten hour or more position will qualify the employee for a referral bonus. If the referred employee's hours change or fluctuate, a review of hours and eligibility will by conducted by the Human Resource Director.
- 3. The Quality Care Services owners will not be eligible for the referral bonus program.

#### Referring a Candidate

- 1. The referring employee will complete a Candidate Referral Form available either from the House Supervisor or Human Resources.
- 2. The candidate referral will remain active for 90 days after the completion of the form. After 90 days, the employee may resubmit a candidate for the referral bonus eligibility.
- 3. If more than one employee refers the same candidate, the employee who completes and submits the form to Human Resources first will be eligible.
- 4. Candidate Referral Forms must be received by Human Resources within 7 calendar days of the date on which the candidate signs the applications form. Even if a job applicant has listed the referring employee on the application, it is still required that the Candidate Referral From be completed and forwarded to HR within 7 days of the applicant signature date.

#### **Payment**

- After the candidate has completed three months of successful employment, the referring employee will receive a \$100 bonus.
   After the candidate has completed 6 months of successful employment the referring employee will receive a \$100 bonus.
- 2. If an employee terminates prior to the referred candidate completing three or six months successful employment, the referral bonus will not be paid.
