

Privacy

This Privacy Policy is designed to explain the specific privacy protections provided on the Island Transit website. The policy explains Island Transit's online information practices with respect to information that we collect about you as a website browser and to process vanpool payments.

Island Transit does not collect personal information unless voluntarily provided to us; "anonymous" or statistical information as described below may be collected, but only to assist in improving this site.

Island Transit does NOT do the following:

- Share any personal information gathered on our website with other agencies or persons unless required by law;
- Create personal profiles or provide personal information to private organizations;
- Collect and/or sell information for commercial marketing.

"Anonymous" information is defined as data that cannot be linked to specific individuals. However, when you visit the Island Transit website, some basic information is automatically collected about your computer as part of the software operation of the website.

We seek to protect your privacy to the maximum extent possible. Nonetheless, some of the information received through this website is subject to the <u>Washington State Public Records Law</u>, and information provided through this site may be made available to members of the public under that law.

Changes to Privacy Policy

Island Transit reserves the right to change this Privacy Policy at any time but will not do so without posting the modified Privacy Policy on our website. We encourage you to review our privacy policy whenever you visit our website to make sure you understand how your information will be used.

Personal Information

When you visit our website, basic information is automatically collected as part of our website's software operation. The type of information collected includes:

- IP address (a computer's unique signature)
- Operating system
- Browser software
- Internet Service Provider
- Navigation information

This information may be used to compile statistics for the purpose of understanding the number of daily visitors, pages most frequently visited, and how long visitors stay on each page. Aggregated statistics may be used to help understand the needs of users and to develop and continually improve our services to better serve those needs. We may also share this information in the aggregate with other third parties.

Cookies

Cookies are another type of anonymous information. Cookies are small text files that a web server, such as Island Transit's, places on a user's computer. The web server only reads a number associated with a browser and is unable to determine any data about a user. When reading a cookie, a web server can tailor its information to the needs of the specific browser, such as when you want information specific to your needs or location called up each time you visit the Island Transit website.

Most browsers are initially set to accept cookies. If you prefer not to have cookies placed on your computer, most browsers allow you to decline cookies. However, if you do so, some of the conveniences they make possible may not be available.

Personal Information

Island Transit contracts with a PCI-compliant hosting provider to collect information for financial transactions, such as vanpool fare payment. The hosting provider's privacy policy will apply.
