Below is a summary of our public community meeting held regarding the above referenced zoning application.

Position: Opposition
Dates of Meeting: April 14, 2015

Location of Meeting: Palumbo Recreation Center, 10th & Fitzwater Streets.

Participating RCO's: Bella Vista Neighbors Association Zoning Committee

Number of Attendees: Approximately 20 excluding zoning committee members

Reason for Position:

The applicant seeks to convert the property from an RM-1 to a CMX-2 zoning district. The Bella Vista Neighbors Association (BVNA) Zoning Committee considers this application a misguided attempt at "spot zoning".

Of the four central dwellings (721-727) that front this block of Washington Avenue, the applicant attempted to convey that the majority of them already contained active commercial uses; however, no supporting evidence was presented. Zoning archive folder research reveals that just 725 Washington Avenue was granted a temporary three year commercial use permit in May of 2013 for a professional office on the 1st floor.

Given the inappropriate form of application for what clearly seemed to be spot zoning, the Committee did not think that such a request should be considered valid, so no vote was taken (i.e. an application for "any use allowed" in a CMX-2 zoning district is without merit on its face).

BVNA therefore opposes this application as written.
