

MESSAGE FROM THE PRESIDENT

Greetings from the officers of the John Walker Family Organization.

Your officers have been actively involved this year in promoting the objectives of the Walker Family Organization. They have met formally on two occasions to discuss plans.

One of the important things accomplished this year is to amend the Constitution so our Executive Secretary can take steps to have our organization declared a non profit Tax Exempt Organization. This means that we will not be liable for taxes on the net of Dues and expenses. An additional benefit is that we will save \$110.00 in postage with each mailing. We can use this money saved for a good purpose in futhering the genealogical work of the organization.

It is planned to hold a Family Reunion again this year, and we hope that a high percentage of the members of the organization will plan to attend. The reunion is to be held in Logan on August 4. Details of the plans are outlined elsewhere in this Newsletter. Inasmuch as Logan is fairly central in location, it is hoped that a large representation of membership will come down from the Upper Snake River Valley, and an equal or larger members from the Salt Lake, Provo, and Southern Utah location. Then, we, hope, we will also have a large representation from the Burley, Twin Falls, Boise valley and adjoining areas. I hope we can give some kind of prize for the largest family representation and also for the family travelling the longest distance to attend.

Our family organization is indeed fortunate to have Rodney W. Walker for our Executive Secretary. He has been so completely dedicated to the work of this organization that we all are the beneficiaries of much genealogical work done on our behalf. Proposed Second Amendment

(To be presented at the reunion on August 4, 1973)

Section 1. The President and Vice President shall be selected in the following manner:

- A) Nominations
 - 1). The Board or a Committee appointed by the Board shall nominate two candidates for each office.
 - 2) Members may nominate candidates by mail prior to the publication of the Newsletter immediately preceding the election reunion.
 - 3) Nominations may be made from the floor at the election reunion.
 - 4) No candidate shall be elected unless he gives his permission.
- B) Announcement of candidates
 With the exception of those candidates nominated from the floor, a
 brief resume' of each candidate shall be published in the Newsletter
 immediately preceding the election reunion. In the event that a
 nomination is made from the floor, the individual making the nomination

shall state why he feels that his candidate should be considered.

- C) Elections
 - 1) Prior to the conduct of elections at the election reunion, this amendment shall be read by the chairman to those members assembled.
 - 2) The vote shall be by secret ballot.
 - 3) The tally shall be made by the members of the Board that are not candidates for either office.
- D) The candidate receiving the highest number of votes shall be considered elected to that office.

Section 2. The Secretary shall be appointed by the President.

Chairman of the John Walker Family Board Appointed: At the second Board meeting held on January 6, 1973, the board members appointed Ralph S. Walker to be the Chairman. He is the Vice President of the Franklin Walker Family Organization and is a son of Delbert Stevenson Walker and Geneve Cutler. His brother Theodore D. Walker was a former president of the John Walker Family Organization. He and his wife Aileen have three children and live in Salt Lake City, Utah.

Dr. Rudger H. Walker Retires From The B.Y.U. Faculty: Dr. Rudger H. Walker retired this spring from Brigham Young University where he served since 1960 as Professor of Agronomy and Dean of the College of Biological and Agricultural Sciences. He and Mrs. Walker were honored at a reception on April 18th by the B.Y.U. students and faculty. On May 10th Dr. and Mrs. Walkers were also honored at a reception by Utah State University in Logan for "Dedication to individuals, University Service, and excellence as institutional and religious instructors." Dr. Walker served as Director of the Agricultural Experiment Station for 17 years, and Dean of the College of Agriculture at Utah State University for 20 years, before going to Brigham Young University. Dr. Walker currently is serving as President of the John Walker Family Organization.
