Ancestry File

The Computer Age has come and make thousands, even millions, of things easier and quicker. The home computer has become popular and became an household "must," for home, business and school.

It is becoming a big help in genealogy work at the Family History Libraries and centers. The Church has established the Ancestry File to make things easier for researchers to locate needed information coming from original records through extraction or from family group records submitted by individuals.

It is understood that the submitters try to do their best to keep the records straight and correct before turning them into the Family History Library for the Ancestral File.

However some discrepancies have been discovered in submitted records in the "Family Search".

For instance, records showed that (1) Robert Walker had 16 children instead of 12, although there are a few duplicates of names among the children. (2) The name of "Thurston," listed as the second child of Robert Walker and Sarah Leager, was misquoted from the surname of Benjamin and Elishu (Walker) Thurston family. (3) From somewhere the name of James instead of Joseph appeared as the fifth child of Robert Walker and Sarah Leager, and he supposedly married Abigail Prudden. Robert and Sarah did not have any child named James.

The Ancestral File showed that (4) Rev. Zechariah Walker had an extra daughter named Mary. Some of us would like to know about her and to have documentary proof about her so that her name could be left intact.

It is felt that it is about time to prepare the genealogy facts on Robert Walker and Sarah Leager, and also their son Rev. Zechariah Walker and his two wives, Abigail and Susanna, and to mail with this Newletter to all Walker folks whose addresses are on the mailing list. They can be used for their references.

At present the 1994 version of the Ancestral File diskettes are now in use at the Family History Library. The old 21 Aug 1992 version contained these discrepancies as said above. Some changes have already been made in the present version. Some errors have not yet been eliminated.

Some attempts are being made to submit the corrected version of the family group sheet on Robert Walker's and Rev. Zechariah Walker's families to the Ancestral File for the next version which may be out in 1996 or 1997.

Copies of the family group sheets (PAF) on the families of Robert Walker and Rev. Zechariah Walker, completed with the LDS ordnances and AFN, will be sent to those who paid their 1995 dues.

ROBERT WALKER OF BOSTON

1. Robert Walker, son of Thomas and Margaret (Bardsley) Walker of Higher Ardwick in the parish of Manchester, was baptized 21 Feb 1607/8 at Manchester, Lancaster, England. He married Sarah Leager, daughter of Jacob and Margaret (Grimwood) Leager in England. She was born about 1610/1611 and was of Hadleigh, Suffolk, England. They emigrated to America in 1630 in the John Winthrop's fleet and settled in Boston by 1631. He joined the Church in 1632, became a freeman 14 May 1634 and was of one of twenty-eight men who founded the Old South Church in 1669. He died 29 May 1687 at Boston, Massachusetts and was buried 31 May 1687. Judge Sewall writes: "He was a very good man, and conversant among God's New England people from the beginning." Sarah died 21 Dec 1695 at Boston, Mass.

To Robert and Sarah twelve children were born, all at Boston,

- 8. Mary Walker (twin of Thomas), chr. 22 April 1649, died young.
- 9. Timothy Walker, chr. 1 Sep 1650
- Eliakim Walker, b 3 July 1652; chr. 4 July 1652;
 d. 30 Sep 1654.
- 11. Mary Walker, b. 1 Nov 1654, chr. 5 Nov 1654.
- 12. John Walker, b 14 July 1656; chr. 20 July 1656; md 1676 Hannah Leager, daughter of Jacob and Ann (Blake) Leager; had a daughter named Hannah who was living unmarried in Boston in 1704; John died 1678/79 at Boston. His wife Hannah md again to Thomas Philips and had a child named Hannah Phillips.

REV. ZECHARIAH WALKER

Rev. Zechariah Walker, son of Robert and Sarah (Leager) Walker, was born 15 Sep 1637 and christened 1 Oct 1637 at Boston, Massachusetts. He was a "debtor" (student) at Harvard College from 1653 to 1655 and was one of 17 students who left the college, probably in protest against lengthening of the course for the degree of Bachelor of Arts from 3 to 4 years. In 1662 he was chosen to serve as the first minister of the newly-organized church at Jamaica, Long Island. He may have had to preach at first in the ordinary, or inn, kept by John Baylie at Jamaica. On 14 Feb 1662/3, Mr. Walker's salary was fixed at 60 pound sterling a year, but sincemoney was scarce, most of the salary was paid in wheat at 6s. a bushel and Indian corn at 3s. 6d. a bushel. The town of Jamaica built the first meeting house, 26 feet square, in 1663 and there Mr. Walker preached till he left Jamaica in 1668. He was " a man of solid attainments, well educated and sound in doctrine, a pungent and powerful preacher and greatly well beloved by the people he served." On 7 Aug 1668 he left Jamaica and became the pastor of the Second Church at Stratford, Conn. He was ordained minister of that church 5 May 1670. He removed to Woodbury with the first settlers of that town and became the first minister there, amd remained there till his death which occured on 20 Jan 1699/1700 and he was buried there. (The American Genealogist Vol. 21 p 67)

In Connecticut about 1669 he married first Mary Prudden, daughter of Rev. Peter and Joanna (Boyse) Prudden. Mary was christened 4 Dec 1641 at Milford, Connecticut and died before 1681.

He married secondly Susanna Rossiter. She was the daughter of Bryan and Elizabeth (Alsop) Roositer and was born 18 Nov 1652 at Guilford, Connecticut. She died 26 April 1710 at Woodbury. Conn.

Three children were born to Zechariah and his first wife Mary,

all at Stratford, Connecticut

- Deacon Zechariah Walker, chr. 22 May 1670; Deputy from Woodbury to the Conn. General Court, May 1720; Deacon of the Church at Woodbury; md abt 1689 Elizabeth Miner, daughter of Thomas and Elizabeth (Booth) Minor; d. 21 Dec 1753. Nine children.
- 2. Abigail Walker, b. 22 May 1670; d young.
- 3. Elizabeth Walker, b 1 March 1673/74; md Deacon Samuel Bull, son of Thomas and Esther (Cowles) Bull; d 22 Sep 1741 at Woodbury, Conn. No issue.
