This assumption of risk includes any injury, harm, loss, or damages incurred in connection with BSA actions or events, such as any games, practices, fundraisers, use of BSA provided equipment, community events, field maintenance, or any similar actions or events.

Further, the undersigned, on behalf of himself or herself and on behalf of the participant or player listed below hereby releases, waives, discharges, and covenants not to sue the BSA, and/or coaches, directors, board of directors, officers, volunteers, sponsors, managers, promoters, and/or lessees or lessors of premises used to conduct any BSA games, practices, or events (collectively, "Releases") from, of, and for any and all liability, losses, damages, claims, causes of action, and demands caused or alleged to be caused in whole or in part by the negligence or other actions or omissions of any of the Releases.
