

ORDINANCE NO. 2020-13

AN ORDINANCE OF THE CITY OF BLACKWELL, OKLAHOMA, AMENDING CHAPTER 28, ARTICLE II, DIVISION 2, SECTION 28-87 OF THE BLACKWELL MUNICIPAL CODE 2019 ENTITLED "SOLID WASTE COLLECTION AND DISPOSAL RATES", PROVIDING FOR A ZERO PERCENT (0%) INCREASE IN SOLID WASTE COLLECTION AND DISPOSAL RATES; PROVIDING FOR REPEALER; SAVINGS; CODIFICATION; SEVERABILITY; EFFECTIVE DATE; AND DECLARING AN EMERGENCY.

EMERGENCY ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BLACKWELL, OKLAHOMA:

Section I. Chapter 28, Article III, Division 2 of the Blackwell Municipal Code 2019 is hereby amended by the amendment of Section 28-87 which shall read as follows:

SECTION 28-87 SOLID WASTE COLLECTION AND DISPOSAL RATES

Effective July 1, ~~2019~~ 2020, and continuing monthly thereafter, regardless of the period of service, the following rates and charges shall be charged and collected for solid waste collection and disposal services:

Charges are based on one weekly pickup

Service	Monthly Rate
Residential pickup (includes apartment units)	\$18.57
Commercial pickup - with additional charge based on size and number of customer, owned containers used	\$27.27

Charges are based on number of dumpsters and number of pickups each week

Share dumpster (limited availability – depending on business location)	\$40.35
One (1) dumpster - one (1) weekly pickup	\$62.20
One (1) dumpster - two (2) weekly pickups	\$90.52
One (1) dumpster - three (3) weekly pickups	\$114.53
One (1) dumpster - four (4) weekly pickups	\$136.24
One (1) dumpster - five (5) weekly pickups	\$158.10

One (1) dumpster - six (6) weekly pickups

\$184.37

Section II. REPEALER. All ordinances or parts thereof which are inconsistent with this ordinance a hereby repealed.

Section III. SAVINGS CLAUSE. Nothing in this ordinance hereby adopted shall be construed to affect any suit or proceeding now pending in any court, or any rights acquired or liability incurred nor any cause or causes of action accrued or existing, under any act or ordinance repealed hereby. Nor shall any right or remedy of any character be lost, impaired or affected by this ordinance.

Section IV. CODIFICATION. This ordinance shall be codified as herein provided.

Section V. SEVERABILITY. If any one or more of the sections, sentences, clauses or parts of this ordinance, chapter or section shall for any reason be held invalid, the invalidity of such section, clause or part shall not affect or prejudice in any way the applicability and validity of any other provision of this ordinance. It is hereby declared to be the intention of the City Council of the City of Blackwell that this section of the Blackwell Municipal Code would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.

Section VI. EFFECTIVE DATE. This ordinance and the rates contained in this ordinance shall become effective on July 1, 2020.

Section VII. EMERGENCY. WHEREAS, it being immediately necessary for the preservation of the peace, health, safety and public good of the City and the inhabitants thereof that the provisions of this Ordinance be put into full force and effect in order to provide for zero percent (0%) rate increase; By reason whereof, this Ordinance shall take effect and be in full force and effect after its passage, as provided by law.
