

**ORDINANCE NO. 2020-19**

**AN EMERGENCY ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BLACKWELL, OKLAHOMA, AMENDING CHAPTER 2, ARTICLE IV ENTITLED “DEPARTMENTS AND OTHER AGENCIES”; DIVISION 1 ENTITLED “GENERALLY”; BY MAKING CERTAIN AMENDMENTS TO THE FAIRGROUND FACILITY RATES AND CODIFIED AS SECTION 2-75 ENTITLED “FAIRGROUND FACILITY RATES”; PROVIDING FOR SAVINGS; SEVERABILITY; REPEALER; CODIFICATION; DECLARING AN EMERGENCY.**

**EMERGENCY ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BLACKWELL, OKLAHOM

Section I: Chapter 2, Article IV, Division 1, of the Blackwell Municipal Code 2019 is hereby amended by the addition of a new Section 2-75 to read as follows:

Section 2-75 FAIRGROUND FACILITY RATES.

A. The following rates and charges are set as guidelines for the use of buildings, facilities and appurtenances at the Fairgrounds<sup>1</sup>:

B. The City/Trust Manager is authorized to develop leases, contracts and other written documents pertaining to the lease of the buildings, facilities and appurtenances and to provide for

their use. In addition, the City/Trust Manager may provide administrative amendments to the rates, in individual cases, when appropriate and in order to increase Tourism for Blackwell.

C. Any and all miscellaneous costs (not listed, i.e. cleaning charges) incurred for the event shall be billed at actual cost and shall be charged and paid by the renter.

Section II. REPEALER. All ordinances or parts thereof which are inconsistent with this ordinance are hereby repealed.

Section III. SAVINGS CLAUSE. Nothing in this ordinance hereby adopted shall be construed to affect any suit or proceeding now pending in any court, or any rights acquired or liability incurred nor any cause or causes of action accrued or existing, under any act or ordinance repealed hereby. Nor shall any right or remedy of any character be lost, impaired or affected by this ordinance.

Section IV. CODIFICATION. This ordinance shall be codified as provided herein in the Blackwell Municipal Code 2019.

Section V. SEVERABILITY. If any one or more of the sections, sentences, clauses or parts of this ordinance, chapter or section shall for any reason be held invalid, the invalidity of such section, clause or part shall not affect or prejudice in any way the applicability and validity of any other provision of this ordinance. It is hereby declared to be the intention of the City Council of the City of Blackwell that this section of the Blackwell Municipal Code would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.


Section VI. EMERGENCY. WHEREAS, it being immediately necessary for the preservation of the peace, health, safety and public good of the City and the inhabitants thereof that the provisions of this Ordinance be put into full force and effect in order to immediately provide for this ordinance amending fairground facility rates; By reason whereof, this Ordinance shall take effect and be in full force and effect after its passage, as provided by law.


