The Pledge of Allegiance to the Flag was observed.

Chmn Willis asked for motion to open the Public Hearing, Councilman Mahany made the motion and Councilman Jackson seconded the motion. Roll call all ayes motion carried. Meeting opened at 7:05PM. Pat was the first to speak and noted his objection to the law. Also Sheri added her objection. Mike Jones interjected his opinion also. Several times Chmn Willis advised the discussion to remain calm. After several warnings and heated discussions Chmn Willis asked for a motion to close the Public comment and table the vote. Councilman Mahany made motion to stop the Public Hearing and return to normal business. Chmn Willis seconded the motion. Roll call all Ayes Public comment closed at 7:20PM.

Dog Control Officer Lackey stated he is catching up on delinquent dogs with a few coming to court. Cars aren't a problem, however there will be some letters going out concerning a few cars. Councilman Jackson made motion to accept the report, Chmn Willis seconded the motion. Roll call all ayes motion carried.

Attorney Vogel looked over the contract with the Humane Society and said it was good. Also Attorney Vogel informed the board of the possibility of Pamela Walsh coming back to Dyer road in the near future.

Highway Superintendent Acomb advised the board that the truck box on Jereme's truck is here.. He stated that there was a fair amount of salt and sand left from the previous winter Also we haven't received all the commitment for salt yet.

Ray also advised the board of an ongoing situation on Acomb Road concerning the area of the Stone Cross. Wayland Town has taken care of this for years by mowing around it. It has been brought to their attention that they no longer can do this as it is in the Town of Dansville legal limits and on private property. Tax payers in the Town of Wayland have pressed the issue. Councilman Jackson made motion to accept Ray's report. Chmn Willis seconded the motion to accept the report. Roll call all Ayes. Motion carried.

The Supervisor's report was looked at. Councilman Mahany made motion to accept the report. Councilman Hartwell seconded the motion. Roll call all ayes motion carried.

Chmn Willis advised the board of his feelings on the planning board coming up with a sub – division law. He feels we need a simple one to protect the tax payers. Also he would like to see the 3 acre law repealed and adjusted to 2 acres. He asked Attorney Vogel if he could come up with something for the next meeting.

There is some work that is needed on the building and the steps. He asked Councilman Jackson if he could spare some time to check the building for problems and report back. He agreed to do this.

Nancy advised that Cheryl Coombes had resigned from the planning board due to a conflict with working out of state. Also that Lynn Smalt was interested in the appointment to fill the position.

The board feels that the decision should be the Planning Boards as they would be working with him. Lynn will be asked to come to Monday's meeting with the Planning Board.

The CEO report was read, there were no questions .Councilman Mahany made motion to accept the report. Councilman Jackson seconded the motion. Roll calls all ayes. Motion carried.

The Board audited General Fund Abstract #4 (59-93) for \$87,187.23, Highway Fund Abstract #4 (35-52) 20,448.01 and T/A abstract #4 (30) for a total of \$110.

There being no further business before the board at this time Councilman Mahany made motion to adjourn, Councilman Jackson seconded it roll call all ayes motion carried Meeting adjourned at 8:00PM.
