The supervisor's report was gone over. Councilman Jackson made motion to accept the report. Councilman Hartwell seconded the motion. Roll call all ayes motion carried.

Nancy asked the board to approve a raise for the Cemetery caretaker. She advised that Ray's part time help gets \$12.00 per hour and that the cemeteries are well taken care of with no problems as well as extra work on them that is not required being done. She presently makes \$10.00 per hour.
