I understand that I am responsible for any and all cost related to the collection of tuition fees, to include but not limited to court and attorney fees if necessary. I understand that I will be charged \$10.00 per week late payment fee if tuition fees are not paid by Tuesday of each week, Monday if you are a Child Care South client.

I understand that I will be charged \$1.00 per minute if I am after 5:30pm picking up my child.

I understand that I will be charged a \$30.00 NSF fee for each returned check.

I understand that I will be charged a fee of \$2.00 each time I fail to sign my child in or out each day.

I understand that I am responsible for providing a one week written notice of intent to withdrawal my child from the center. I also understand that I am responsible for the tuition for the one-week's notice. No exceptions!

In return for services I receive, I agree to pay \_\_\_\_\_ weekly in advance to Cradle 2 Crayons according to the program policies.

I understand that if my child is enrolled full time, I am responsible for the full tuition for each week regardless of how many days my child actually attends. The **ONLY** exception to this is a **PREARRANGED** vacation, when the **DIRECTOR** has been given a **one week written** notice that the child will be absent, one-half tuition is due for the week of absence. It must be paid the Friday before the week of the vacation, or the discount will not be given.

I understand that if my child is enrolled part time, that I am responsible for tuition for the days my child is supposed to be in the center regardless of whether or not my child actually attends.

I understand that there is no credit given due to child illness, school holidays or for closings due to emergency situations, inclement weather or Acts of God.

If there is an outstanding balance on Wednesday, your child will NOT be allowed to enter the center on that day until the balance has been cleared.

If you have given notice for your child's last day, the tuition payment is due up front for their final week.

I understand there is NO ADMITTANCE between the hours of 10:00 a.m. and 2:00 p.m. unless we are provided with a doctor's excuse for that morning.

I understand that if I am a Child Care South, DHR, or JOBS Client that I am only entitled to five days absence per month, ten days with medical excuse covering at least five. I also understand that if I exceed my allowed time I will be responsible for the full regular tuition rate that is charged by Cradle 2 Crayons. I also understand that if the center is closed for a holiday on Monday, and I am a Child Care South, DHR, or JOBS Client, my tuition will be due the Friday before.

Cradle 2 Crayons will only hold your child's belongings for one week past withdrawal. If items are not claimed by the end of the week they will be donated to Good Will. We will not release any items left here until the account is paid in full.

All tuition deposits and/or fees are NON-refundable. This includes tuition paid in advance.
