#### **PRIVACY POLICY**

This policy is written to notify you of your rights under the new data protection laws that come into effect on the 25<sup>th</sup> May 2018. This policy may be updated from time to time.

Rose Export Ltd Trading as Rose Removals and Storage assure you that we are committed to safeguarding the privacy and security of you, our customer and website visitor. We fully appreciate and respect the importance of data privacy and security on the Internet and understand and comply with our legal and regulatory obligations.

Our privacy policy explains how we look after, handle and use all personal information provided by you. It also informs you of your privacy rights and how you the law protects your personal information.

For the purpose of European Union Data Protection legislation, we (as defined and detailed in our Site) are the data controller.

#### We will at all times:

- Keep your personal information safe, secure and private;
- Never sell your personal information;
- Collect, keep, use your personal information for genuine business purposes only;
- Only pass your personal information to trusted partners if we have your consent;

## **Data Protection Law and Your Personal Information**

The law states that we must have one of the following reasons to collect and use your personal information:

- To enter into / fulfil a contract with you
- When it is in our legitimate interest and/or you have given your consent

#### **Collection of Personal Information**

# Personal information may be collected from any of the following sources:

- When you contact us by phone or in person at our offices
- By email, letters or other documentation (such as survey document)
- Via our Website / Facebook page
- When we attend your premises to carry out an estimate
- When you leave a review / provide customer feedback

- Information that you provide by filling in forms on our Site, including but not limited to, information provided at the time of registering to use our Site, subscribing to any service, posting material or requesting further services.
- Any additional information required to enable us to provide you with a quotation and / or fulfil a contract
- Customs documentation required for export / import of goods such as but not limited to Passport, shipping manifest, Inventory.
- Any details provided for enquiry, complaint, claim or any other in relation to our services
- Details of your visits to our Site, including, but not limited to, traffic data, location data, weblogs and other communication data, whether this is required for our own billing purposes or otherwise and the resources that you access.

# <u>IP ADDRESSES / COOKIES - Information collected from our Website or other Internet Service or Apps</u>

- We may collect information about your computer, including, where available your IP address, operating system and browser type, for system administration. This is statistical data about our users' browsing actions and patterns, and does not identify any individual.
- For the same reason, we may obtain information about your general internet usage by using a cookie file which is stored on the hard drive of your computer. Cookies contain information that is transferred to your computer's hard drive. They help us to improve our Site and to deliver a better and more personalised service. They enable us to:
- Estimate our audience size and usage pattern;
- Store information about your preferences, and so allow us to customise our Site according to your individual interests;

- Speed up your searches; and recognise you when you return to our Site.
- You may refuse to accept cookies by activating the setting on your browser which allows you to refuse the setting of cookies. However, if you select this setting, you may be unable to access certain parts of our Site. Unless you have adjusted your browser setting so that it will refuse cookies, our system will issue cookies when you use our Site. The "Help" menu of the toolbar on most browsers will tell you how to prevent your browser from accepting new cookies, how to have the browser notify you when you receive a new cookie, or how to disable cookies altogether. #### What cookies are used on our Site

- The cookies we and our business partners use on our Site are broadly grouped into the following categories:

- **User Cookies** We use cookies to improve your experience by remembering your preferences so we know how you like to use our Site. Examples of this would be remembering you so that you are served with the same content or to remember you when you come back to our Site.
- Social Sharing We use third party cookies to allow you to share content directly on the social networking/sharing sites like Facebook, Twitter or Google+. Examples would be if you wanted to "like" or "tweet" about us or our products or services. Please see our "Third Party Cookies" section below for more details.
- Interest-Based Advertising You will have noticed that when you visit websites you will be shown adverts for products and services you may wish to buy. The money made by website owners for showing third party adverts on their websites often pays for the cost of running the website and therefore usually allows you to use the website without having to pay a registration or usage fee. To try and ensure that the adverts you see are relevant to you third party cookies may be used to collect information about the types of things that interest you, for example websites you visit and the geography that you are based in. Having these cookies does not increase the number of adverts you will be shown, but simply makes the adverts you see more relevant. ## **Retention of personal information**

We retain the personal information we collect from you for as long as the information is relevant to our business purposes including our legal obligations / requirements or until you request that we remove the data.
