<u>Committee Reports:</u> *Membership Committee:* No report presented.

## General Business:

- **1.** *Insurance:* Jarv Osborne informed members that he spoke to John Thomas today. Based on the quote, Jarv will request an invoice and if we have questions regarding the coverage, we will contact John. Clarification will be made regarding Directors and Officers to ensure that volunteers are covered. Members agreed that the quote of \$162 for liability insurance is an acceptable rate.
- 2. Heritage Day: Heritage Day will be cancelled for 2020 because of the COVID-19 pandemic. At this time, under the provincial emergency order, the museum is not permitted to be opened and no gathers of more than 5 people is allowed. The Council for the Township of Armour decided at their April 14, 2020 meeting that they will not be hosting the event. Charlene informed Members that deposits that were made for attractions are being held by the companies for next year's celebration. The Firefighter Challenge has been cancelled. It is difficult to plan for any event at this time. Members agreed to cancel Heritage Day for July 11, 2020 but will consider hosting an open house in August should conditions change and depending on provincial requirements.

# New Business:

*Summer Student:* Our summer student from 2019 will not be returning to work for the Historical Society in 2020. Diane was informed by Riley that he is moving to Ottawa at the end of May. Because of the COVID-19 pandemic, Members are unsure of staffing needs but note a benefit in having staff without being open to the public. Diane Brandt mentioned hiring Kendra Kellas back part-time for 2020 to clean and Members agreed to hire Kendra back at a rate of \$14 per hour.

*Advertising:* Members discussed advertising the heritage centres for 2020 and decided to forfeit advertising in the Almaguin Community Guide or other publications because of the uncertainty in the operating season. **Motion to not advertise the heritage centres in publications for 2020: Moved by Diane Brandt, Seconded by Jarv Osborne. Carried** 

*Audit:* Jarv Osborne informed Members that Dalene MacDonald will file our income tax. This will be her last year of service. Bruce Campbell and Betty Caldwell have not completed the audit to date because of the pandemic but Members agreed to deliver the books to the accountant regardless. An audit will be completed as soon as we are able.
