11 REPORT FROM COUNTY COUNCILLOR GOODRICK

Councillor Goodrick reported

- a) NYCC have to make another £10 million savings this year.
- b) The Allerton Park Recycling Plant is now open and 95% of household waste is now being Recycled. Power generated is sufficient to serve Harrogate and the plant is fuelled by energy generated from the Anaerobic Digester. Income from these is being generated for NYCC. Guided tours round the site are available
- c) School Transport for Special Needs Children has up to date been free but due to the need to make cuts in costs parents of these children will be expected to pay towards the cost of transport.
- d) There is to be a review of Adults Health and Social Care
- e) Councillor are pushing to have illuminated speed matrix installed in all villages but Highways Department are refuting the effectiveness in reducing speeding traffic

13 REPORTS FROM PARISH COUNCILLORS

Broadacres Housing Association has advertised the 2 properties for rent at Pecketts Close but again there is confusion regarding who is able to bid. Colin Huby has been contacted

Millfields estate is almost complete. Councillors were invited for a viewing and were impressed with the size and quality of the houses. York Housing have confirmed that to date 2 of the shared ownership properties have been allocated with another one under negotiation. Interest is low due to problems with prospective buyers obtaining mortgages. Councillors expressed their concerns that they will be allocated to people from outside the parish. The official opening of the site will be on 6th July and Councillors will be invited along.

It is understood The Castle Inn will be re-opening soon.

Hedges of certain properties are encroaching on footpaths reducing the width and subsequently making it difficult for people with children's buggies and those with mobility scooters. A note to be put in the Village News

The Grass Cutting contractor has started this season's cuts and he is to be reminded to strim the verge up to the Village Sign on Cornborough Road.

Councillor Dodd has taken photographs of areas where daffodils are sparse and he will liaise with one of the members of the Gardening Club regarding planting of additional bulks, at cost to the Parish Council

It has been reported that a black dog has been worrying sheep in the Mill Lane Area. A notice to be put in the Village News reminding dog walkers to keep their dogs under close control when near livestock.
