1. APOLOGIES OF ABSENCE None.

2. DECLARATION OF INTERESTS None.

3. MINUTES

The council resolved that the minutes of the meeting held on the Friday 13th September 2019 were agreed and signed by the Chairman.

5. MATTERS ARISING FROM THE MINUTES

(a) It was noted that the planters on Old Mill View have now been removed to create additional car parking.

(b) Clerk read out the reply email from Castle Howard regarding the recent cycle race through the village.

(c) Clerk read out the reply email from Graham Atkinson, Petroleum Officer @ NYCC regarding the storage of aviation fuel at Cottage Farm. After discussion it was agreed for the Clerk to ask Graham if he could make further investigations.

(d) The Clerk advised that RDC had confirmed that the Village Hall car park project does fall within the scope for the CIL payment. They advised that the funding is for the provision, improvement, replacement, operation or maintenance of infrastructure or anything else that is concerned with addressing the demands that development places on the area.

6. CLERK'S REPORT

(a) To discuss any update on the village tree survey – Councillors Dodd and Smith advised that all trees in the village have now been identified, including locations and species. After discussion it was agreed for the Clerk to instruct Lewis Tree Surgery to carry out the priority 1 remedial works with a view to them carrying out the priority 2 work in the Spring. requested for all trees within the Conservation Area. Councillors Dodd & Smith to identify which trees require planning permission.

7. PLANNING

a. The following planning applications was received this month:-

19/00888/FUL Land Rear of Park View, Finkle Street, Sheriff Hutton

Erection of 2no. four bedroom detached dwellings with detached double garages together with formation of vehicular access and associated landscaping.

Decision - Sheriff Hutton Parish Council OBJECT to this planning application, on the following grounds - No attempt has been made to alleviate any of the concerns raised in the previous application; over development of the area, since the last application was approved Sheriff Hutton has seen an overfill of large, expensive houses; inappropriate larger type of houses proposed which would be unlikely to attract families into the village or those needing to downsize; the scale of the proposed houses is intrusive; the access of the proposed location, with visibility towards Sheriff Hutton limited by a bend in the road; the width of the access road is unacceptable and inaccurate on the plans submitted; the limiting capacity of the existing water and drainage systems. The recent incidents of flooding and standing water have been experienced by the adjacent residents and this has been exacerbated by recent climate changes; the ecological impact of replacing existing natural boundary hedging with fencing; concerns surrounding the existing medieval ridge and furrow field system; the development would have a material adverse impact on the amenity of the present occupants of neighbouring land, including a loss of privacy to existing houses.

19/00829/HOUSE 1 Glebe Cottages, Church End, Sheriff Hutton Erection of first floor extension. Decision – No Objection.

19/01014/HOUSE Laburnum Cottage, West End, Sheriff Hutton Erection of replacement outbuilding to form artists studio for personal use of applicant. Decision – No Objection.
