RENTAL APPLICATION REQUIREMENTS

- 1. Application Fee is \$40 with cash, check, money order or credit card.
- 2. Application required for every individual living in the property above the age of majority.
- 3. Headley Realty properties require an adult above the age of majority to apply for tenancy in any property Headley Realty has under management contract.
- 4. Criminal background, eviction history, and credit checks are completed on all applicants above the age of majority.
- 5. Headley Realty contacts former landlords that are listed in the application by applicant.
- 6. Copy of valid government ID is required for every applicant above the age of majority.
- 7. All leases are 12 months unless otherwise advertised or negotiated.
- 8. Deposits and a signed lease are required for a completed legal lease.
- 9. Co-Signers are allowed but must be listed on the lease if approved for tenancy.
- 10. All applicants need a 650 FICO credit score or higher to be approved for tenancy unless otherwise negotiated.
- 11. Applicant's income will have to be more than 2 times the rent and verified with bank statements, canceled checks, or pay stubs.
- 12. Pet fee is at landlords discretion to be non-refundable and ¼ of 1 months' rent or \$50 per month additional pet fee on all properties that are accepting pets.
- 13. Security deposits are equal to monthly rent amount on all properties and cannot be used in lieu of last month of rent.
- 14. All residents that will be residing in the property must be listed by name in the other residents' section of the application. Written approval is required by Headley Realty P.C. to allow new residents not stated on the application.
- 15. All rental applications must be filled out in full to be accepted by Headley Realty, P.C.
- 16. All rental applications will be process within a reasonable period. Agents will update applicants accordingly if they have any questions or concerns.
