Now more than ever the public is interested and engaged in what their councils and boards are doing and want to have meaningful input. Expert opinion. Tight budgets. Electoral platforms. Public input. Everyone agrees that public engagement is important, but decision-making can feel like a crowded space.

As the leader in your organization, understanding the importance and having the skills to assist your elected officials and support your staff team with public engagement is critical. To succeed, engagement efforts will require your organization to ask authentic questions, get beyond the "same ten people," and account for the practical constraints faced by decision-makers.

This workshop will help you address the tough questions of sponsoring and planning public engagement initiatives. Participants will explore tools and principles to help design high-quality public engagement processes and to clarify strategic intentions before hitting the streets. Using local government case studies and applying the concepts to their current projects, participants will leave with practical skills to use in their communities.



**Robin Prest** is the Acting Executive Director at Simon Fraser University's Morris J. Wosk Centre for Dialogue, where he supports a range of community-engaged initiatives and strengthens the capacity of governments and citizens to work collaboratively on policy decisions. He regularly supports elected officials and senior decision-makers to improve the clarity and impact of public engagement initiatives, and to embed engagement within organizational cultures.



**Brian Carruthers** is the CAO for the Cowichan Valley Regional District and prior to that was the CAO at the Regional District of Central Kootenay and City of Williams Lake. Brian has worked in local government for almost 11 years.

Working as a CAO has its risks. One of the riskiest times is immediately following an election when a newly elected council or board decides it is time for a change. In the extreme, that can mean a change in CAO. There are the financial and legal aspects to a termination of course, and there is the emotional aspect. In part one of this session, learn from an experienced labour lawyer about the legal considerations and protections in the case of termination with and without a contract and what other CAOs have included in contracts to protect them in the case of termination.



**Dean Crawford** is a partner at Pulver Crawford Munroe LLP. He practices in the area of labour and employment law, including employment litigation, human rights proceedings, labour relations, workers compensation and employment standards. Dean works closely with employers and employees on preventative steps to resolve workplace issues quickly and efficiently. He also represents clients in litigation and has considerable experience

acting for both employers and employees before the B.C. Court of Appeal, the B.C. Supreme Court, the B.C. Human Rights Tribunal, WorkSafe BC and labour arbitrators. Dean is frequently called upon to advise clients on executive employment agreements and has considerable experience in drafting such agreements.



**Guillermo Ferraro** joined the Town of Ladysmith as CAO in June 2016. He has 17 years of local government experience, including as a Director of Legislative Services, Information Technology and Communications, Manager of Revenue Services and Manager of Business Applications.

DEALING WITH THE FALLOUT: Part 2 – Moving On and Rising Above

Part two of this session will focus on the supports that are available for CAOs who have been terminated or are facing that possibility. Whether it is precipitated from a change in council or board of your community or from other circumstances, the involuntary departure from your organization can come as a shock, even if it was somewhat expected. When the termination occurs, the immediate emotional aspects leave many individuals not knowing what to do or where to turn for advice and assistance.

Understanding that you own your own career, what you can do, what supports are out there and how can you develop a transitional plan to help you feel encouraged about the possibility of moving forward and thriving after termination are all important elements of the transition. This session will include a discussion of LGMA Career Transition Service to support CAOs through this process.

It can be very challenging dealing in a political environment and facing both internal (council/board) and external (public, media, etc.) pressures. As a public servant in local government you are guided in your work and professional conduct by certain ethical principles. Exhibiting ethical leadership with your new council or board sets an important tone and expectation of behavior for the next four years. Some topics to be discussed include:

- Establishing a respectful environment/relationship between council/board and staff
- Building ethical and accountable decision-making with council/board to deliver its vision and your senior management team to be effective and responsive
- Taking a leadership role in ensuring facts are presented (how to deal with the fake news syndrome perpetuated in social media). How do you create a business process to combat unsubstantiated misinformation or attacks on staff?



Alberto De Feo is the CAO of the District of Lake Country. He has a 30-year career in local government which began as CAO in Italy prior to serving as CAO in several local governments across BC. Alberto joined the UNBC Political Science Department in 2009 as an Adjunct Professor and teaches courses in local government administration, services, ethics, leadership, and project management.



**Stuart Horn** is the CAO of the Regional District of Central Kootenay. He has worked in local government for over five years. Prior to his local government career, Stuart spent 11 years specializing in forensic accounting.



**Janette Loveys** has been the CAO of the Sunshine Coast Regional District since 2015. She started her public sector career in 1990 for the Province of Ontario, and has worked for the Region of Waterloo, City of Guelph, City of Welland, and the Capital Regional District.

Devastating flood and wildfire seasons such as 2017 and 2018 are expected to become more common. The experts predict that shifts in weather patterns will only increase – the trajectory for these types of events is increasing. To support resilience, we need to invest and align our interests and efforts as part of a collaborative disaster resilience approach. Local governments are key players in the conversation around roles, responsibilities and delegation. Bob Lapham will facilitate an interactive discussion focused on the following elements:

- The role of Emergency Management BC supporting local governments managing states of emergency
- Collaboration and delegation of emergency management responsibilities between and amongst local governments
- Local government business continuity during a state of emergency
- The role of local elected officials during an emergency event and after an emergency is declared
- The role of the Provincial government during emergencies (and emergency preparedness support)



**Bob Lapham** is the CAO for the Capital Regional District and the Capital Regional Hospital District. He joined the CRD in 2006 as General Manager of Planning and Protective Services and was appointed CAO in February 2013. Bob is a Registered Professional Planner and Local Government Administrator by training, with more than 30 years of local government experience.
