Smoking is prohibited (NO EXCEPTIONS) in our vehicle. The contracted name on the reverse side of this contract is fully responsible for his/her guests in every regard to this agreement. Client assumes full responsibility for any damage to this vehicle or damage to any other property caused by the client or his/her guests, whether by accident, neglect, or intent. Client also assumes responsibility for any overtime fees and authorizes Lynette's Limousine Service, Inc. To charge the credit-card account number we have on file the charges to be made to cover these costs or any others due and not collected at the end of charter. Our company and chauffeur assume NO responsibility for articles left in our vehicle(s) or on our property at any time.
