TRANSPORT	VERVOER
The Department of Transport has published the newest addition to the Regulations pertaining to certain travel, in a gazette dated 04 May 2020	Die Departement van Vervoer het 'n opgedateerde Regulasie gepubliseer, met betrekking tot sekere aspekte van reis. Dit is vervat in 'n Regulasie gedateer 04 Mei 2020
The gazette deals, amongst other with: a) Improved hygiene control; b) Embarkation of passengers from public transport; c) Prohibition of certain public travel during Level 4; d) Times; e) Loading capacity; f) Validity of licenses.	Die gazette handel onder andere met: a) Verhoogde higiëne beheer in voertuie; b) Die hantering van passasiers (en hul veiligheid); c) Die verbod op sekere reise; d) Tye van funksionering; e) Passasiers kapasiteite; f) Geldigheid van Lisensies.
The highlights of the regulations include detail regarding "Covid" type measures to ensure the safety of occupants and regulation of time of operation from 05h00 to 20h00, with a grace period for loading to 21h00.	Die belangrikste sluit in besonderhede oor "Covid" maatreëls om passasiers se veiligheid te verseker en regulering van die tyd van funksionering tussen 05h00 en 20h00 met 'n uur gracie vir laai – 21h00.

Please note in particular the prohibition on long distance interprovincial travel.

Item 7 of the regulation is clear:

“All long distance inter- provincial travels are prohibited for the duration of Alert level 4 except when authorized by the Minister by notice in the Gazette.”

In addition to this, it also gives a detailed indication of the percentage (of passengers) allowed viz the licensed carrying capacity of the vehicle, and a 90-day grace period to renew lapsed licenses.

Let veral op die verbod op langafstand intra-provinsiale reis.

Item 7 van die regulasies stel dit duidelik:

“All long distance inter- provincial travels are prohibited for the duration of Alert level 4 except when authorized by the Minister by notice in the Gazette.”

Verder word detail rakende die vasstelling van die persentasie besetting van verskeie tipes voertuie , met verwysing na die hoeveelheid passasiers waarvoor dit gelisensieer is, en ’n 90 dae periode om lisensies te hernu.
