**The DBE published a "Standard Operating Procedure" document related to Covid-19**

**STANDAARD OPERASIONELE  
PROSEDURES VIR ONDERWYSSEKTOR**

**Die DBO het 'n "Standaard Operasionele Prosedure" dokument gepubliseer wat verband hou met Covid-19**

1. It spans topics such as:
  - a) Steps to prevent Covid-19:
    - roles of the SMT, SGB and other staff;
    - access control;
    - screening;
    - hygiene; food preparation; and
    - social distancing.
  - b) Management of Covid-19 cases at the school:
    - i. Learner appears to be ill;
    - ii. If Covid-19 is confirmed;
    - iii. Exposure to a suspected or a confirmed case of Covid-19.

1. Dit omvat onderwerpe soos:
  - a) Stappe om Covid-19 teen te werk:
    - die rol van die SMT, BL en ander personeel;
    - toegangsbeheer;
    - sifting ('screening');
    - higiëne; voorbereiding van kos; en
    - sosiale distansiëring.
  - b) Die bestuur van Covid-19 gevalle by die skool:
    - i. Leerders kom siek voor;
    - ii. Indien 'n Covid-19 infeksie bevestig word;
    - iii. Blootstelling aan 'n moontlike of 'n bevestigde geval van Covid-19

2. Procedures for supervisors:
  - i. Employee tests positive; Employee exposed to a confirmed case;
  - ii. Employee exposed to an unconfirmed Covid-19 case;
  - iii. Employee appears ill;
  - iv. Employee refuses to report for duty;
  - v. Management of Employee absenteeism.

2. Prosedures vir toesighouers:
  - i. Werknemer toets positief; of werknemer blootgestel aan 'n bevestigde geïnfecteerde geval;
  - ii. Werknemer blootgestel aan 'n onbevestigde Covid-19 geval;
  - iii. Werknemer kom siek voor;
  - iv. Werknemer weier om aan te meld vir diens;
  - v. Die bestuur van werknemer afwesigheid

5. Emotional support
