For each full four week period during the terms of this Agreement, Lessee shall pay the Per 4 Week rental rate set forth above. Should this Agreement be terminated or canceled before the expiration of any full four week period, Lessee shall pay the Per Week rental rate for each full week, and the Per Day rental rate for each additional day or portion thereof, completed prior to the date of termination or cancelation of the Agreement. In addition to the above, Lessee shall pay all applicable sales, use or other taxes.

Rental is based on maximum use for each Unit of 160 hour per four week period. 40 hours per week or 8 hours per day. If Lessee's use exceeds these hours for any given time period as determined by any Unit's hour an Excess Usage Charge as noted in the above rate schedule.

Lessor shall invoice Lessee at periodic intervals for the rental specified above, any Excess Usage Charges and any other charges, and Lessee shall pay the same within 15 days after the date of Lessor's invoice.
