## Vacation Care and Pupil Free Day

### BRING YOUR OWN (BYOD) AGREEMENT POLICY



Children wishing to use their personal devices including iPad, phone, tablet or portable devices whilst enrolled to attend Vacation Care or a Pupil Free Day at Grays Point Activity Centre (GPAC) must read and agree to signing this BYOD Agreement in the company of a parent or guardian.



A warning system will be used for any misuse of devices. If a child does not adhere to the BYOD and it is a severe breach, guardians will be notified immediately. Alternatively, a three-phase warning system will be in place and maintained for the entire calendar year.



I agree that I will abide by the Centre's BYOD Agreement Policy and that:

- ✓ I will not hack or bypass any hardware, and software security implemented by GPPS or GPAC and will not use Grays Point Public School (GPPS) or GPAC server or Wi-Fi network.
- ✓ I will not have any internet access. Therefore, I cannot send messages, use Messenger/ Kids Messenger, TikTok, Facebook, Instagram, Facetime, Twitter, Snapchat, YouTube or any other Application that may require internet access, and share with others.
- ✓ Devices should have the volume turned off or at a respectful low volume, headphones are unfortunately not an option.
- ✓ I will use my device only during assigned usage times.
- ✓ I will not attach any of GPAC's equipment to my device without the permission of the Centre.
- ✓ Photos and videos are not permitted to be taken or shown whilst in the care of GPAC including excursions.
- ✓ Any application must be age appropriate and rated under 12 years of age.
- ✓ Devices, content, music, or applications must not be shown or shared with any other child especially children younger than me.
- ✓ I will stay safe by not giving my personal information to strangers or my log in or password details with others.
- ✓ I will not use my own device to knowingly search for, link to, access or send anything that is:
  - Offensive
  - Pornographic
  - Threatening
  - Abusive or defamatory
  - Considered to be bullying.
- ✓ I will report inappropriate behaviour and material immediately to an Educator.
- ✓ I understand that my activity on the internet is recorded and these records may be used in investigations or for other legal reasons.
- ✓ I acknowledge that I am responsible for my device or accessories and GPAC will not be held responsible for any damage or theft.
- ✓ Educators can at any time view content or ask a child to surrender their device.

**As a child attending Grays Point Activity Centre, I understand and will abide by the BYOD Agreement Policy and conditions. I Acknowledge that any violation of the Policy may result in the loss of my device privileges as well as other disciplinary action.**
