In 2017 Stichting Bo Hjelt Foundation have come to an agreement for a contribution for a S/Ship (TBC) Role of integrin receptors in neurulation and neural tube defects project. The total contribution is \in 135.000,-. At the end of the year 2018, there remains an amount of \in 45.000,-.

In 2018 Stichting Bo Hjelt Foundation have come to an agreement for a contribution for a Telomeres project. The total contribution is \in 90.000,- and, if applicable, 12.5% for overhead. At the end of the year 2018, there remains an amount of \in 45.000,-.

Contributions to extra projects

In 2016 Stichting Bo Hjelt Foundation have come to an agreement for a contribution for a double-blind study for the elimination of urinal incontinence in the beginning of the life of Spina Bifida patients. The total contribution is \in 130.000,-. At the end of the year 2018, there remains an amount of \in 106.100,-.

General

Place of residence

The activities of Stichting Bo Hjelt Foundation consist mainly of the support and promotion of medical research for the prevention and cure of the disease Spina Bifida and the support and promotion of assistance to patients suffering from mentioned disease.

Compared with previous year, there have been no changes in the accounting policies applied.

Accounting policies for the statement of income and expenses

Result

The statement of income and expenses is the balance of the donations on one hand and on the other the expenses for the year. Donations are recognised in the year they are realised; expenses are recognised when foreseen.

Contributions to research projects

Expenses for support and promotion of medical research for the prevention and cure of the disease Spina Bifida are based on the historical cost convention and attributed to the financial year to which they pertain.

Other operating expenses

Expenses are determined on a historical basis and are attributed to the reporting year to which they relate.

Financial income and expenses

Interest income are recognised on a pro rata basis, taking account of the effective interest rate of the assets to which they relate.

Interest expenses are recognised on a pro rata basis, taking account of the effective interest rate of the liabilities to which they relate. In accounting for interest expenses, the recognised transaction expenses for loans received are taken into consideration.

Contributions to extra projects

Expenses for extra projects related to the field of Spina Bifida, besides the general research contributions, are based on the historical cost convention and attributed to the financial year to which they pertain.
