We persevere by the grace of our Lord Jesus Christ through a challenging season in the life of our ministry. In early July, we had our first occurrence of the coronavirus. Due to the obvious difficulty of social distancing in prison, the virus spread quickly. All three of our barracks are on quarantine. We are thankful we were able to honor Group 29 with their completion certificates on July 1 prior to the outbreak.

Members are allowed to go out on the yard in shifts for a couple of hours daily and there seems to be less anxiety than there was initially. Classes have been halted and counseling staff has been temporarily working out of the PTF administrative office at the prison. Staff has been able to help fill in the gap where our members were working on our front lawn and in cleaning our office areas. We are thankful we have some form of communication with our members while they are going through this process without directly exposing ourselves. We have been able to get encouraging letters, scriptures and inspirational videos to them weekly.

The first four times I got out of prison I left with a \$100 gate check and without a clue. The fifth time will be different.

You've heard the story: My parents divorced when I was 9. By 15 I was a high school dropout with a serious meth problem that sent me to juvie several times as a teenager.

I am now 32 with more than 22 arrests, a habitual offender on my fifth prison sentence. Doing time never made my life or my character better. Actually, it made them worse. On each of those four occasions I left prison on the Boomerang Express. I needed something different. I needed true change, inside-out change.

Early on in my current sentence, I kept hearing about Pathway to Freedom. When I was denied work bama as well as program director at release I really felt I had no other option. It was like God closed the doors he wanted closed but opened the door he wanted open. So I started doing my research on the program and re-entry kept sticking out to me. I world for the past 20 years. Jon has signed up and was accepted.

I gave my life to Christ here on and work through my issues. I started September 27, 2019. This was a game- forming new habits and my whole paradigm changed. Now I can say — proudly — I'm a PTF graduate.
