HAPPY CANYON COURT CONTRACT

This "HAI	PPY CANYON COURT CONTRACT" is entered into between HAPPY
CANYON COMP.	ANY, INC, which is referred to in this Contract as "Happy Canyon" or as
"we" and	, who is referred to in this Contract by name or as "you."
	RECITALS

- A. Happy Canyon has selected you to serve as a Happy Canyon Princess. As a Happy Canyon Princess, you will be a very public representative of Happy Canyon, and in a more general way of Eastern Oregon. This means it is and will be important for you to conduct yourself at all times in a way that is consistent with the high standards and ideals of Happy Canyon, and of your community in general.
- B. The purpose of this Contract is to identify in a general way some of the responsibilities and duties you will have as a Happy Canyon Princess; to identify some of the expectations that Happy Canyon has of you in terms of the way you conduct yourself, both when you are acting as a Happy Canyon Princess, and in your private life; and to explain some of the additional terms you agree to as a Happy Canyon Princess.
- C. By signing this Contract, you are agreeing to perform all of the responsibilities and duties of a Happy Canyon Princess; you are agreeing to meet (or exceed) the expectations Happy Canyon has of you in terms of the way you conduct yourself; and you are agreeing to all of the terms set forth in the Contract.
- D. It is not possible to list all of the responsibilities and duties you will have as a Happy Canyon Princess, as those responsibilities and duties may change from time to time; it also is not possible to list all of the ways you can and cannot conduct yourself as a Happy Canyon Princess. By signing this Contract, you are also agreeing and recognizing that whether you have performed your responsibilities and duties, and whether you have met the expectations Happy Canyon has of you in terms of the way you conduct yourself, will be determined solely by Happy Canyon, and by its Board of Directors, based solely upon the exercise of their discretion.

AGREEMENT

- 1. <u>Responsibilities and Duties:</u> In general, your foremost responsibility and duty to Happy Canyon is to serve as a public representative and ambassador of Happy Canyon, and to project in public and in your private life an image consistent with the high standards and ideals of Happy Canyon, and you agree to do this. Specifically, but without limitation, you also agree:
 - (a) Happy Canyon Court duties come first throughout the year, before work, school events or other events including, but not limited to vacations;
 - (b) That you will perform to the very best of your ability such specific responsibilities and duties as may from time to time be assigned to you;
 - (c) That you will be on time for all required functions;

- (d) That you will make sure your appearance is at all times appropriate to your position as an ambassador of Happy Canyon, and that you will be dressed and groomed appropriately for all required functions. Parents must wear name badge at all times when involved with Happy Canyon functions.
- (e) That you will write a thank you for all gifts given within the time frame given to you by the Happy Court Director. You will be required to keep a log of all gifts received and all thank you's written. In order to receive your scholarship check it will be mandatory that this log be turned in after all activities have ended in September.
- 2. <u>Conduct.</u> We expect you to, and you agree to, conduct yourself at all times in a way that is consistent with the high standards and ideals of Happy Canyon, and of your community in general, as determined by Happy Canyon and by its Board of Directors, based solely upon the exercise of their discretion. Specifically, but without limitation, you agree:
 - (a) That you will not drink alcoholic beverages, or take or use illegal drugs, during the term of this Contract.
 - (b) That you will not smoke cigarettes or use tobacco during the term of this Contract.
 - (c) That you will not get married, or become pregnant, during the term of this Contract.
 - (d) That if you have a boyfriend during the term of this Contract, your contact with him will be discrete, and that you will not engage in any public displays of affection that would be inconsistent with the high standards and ideals of Happy Canyon. If you have a boyfriend during the term of this Contract, there will be no contact with him during Happy Canyon functions.
 - Boyfriends do not accompany court members or their families during Happy Canyon related functions. This includes travel to and from Happy Canyon functions, as well as during these functions.
 - (e) That you will not compete for or accept any other titles or positions which interfere with your ability to perform your responsibilities and duties as a Happy Canyon Princess;
 - (f) That you will immediately report to your director or chaperone any condition or problem which may, in the discretion of Happy Canyon, impair your ability to perform your duties and responsibilities, or which may constitute a breach of this Contract;
 - (g) For the duration of this contract, if you maintain a Facebook, MySpace or any other Internet or electronic meeting space, you agree to maintain your personal pages such that they reflect well upon yourself and Happy Canyon. You agree to make the Happy Canyon director a "friend" on any

and all web pages. If in the discretion of the Happy Canyon Director there are items that do not reflect well upon you or Happy Canyon they are to be removed immediately or if this is not possible, at the earliest opportunity to access the pages in question. In addition any pictures or content that feature you that appear on other web pages maintained by others that do not reflect well upon you or Happy Canyon could result in disciplinary actions.

- 3. Our Discretion: If, in the sole discretion of Happy Canyon, or its Board of Directors, you breach this Contract, or in any way conduct yourself in a way that is inconsistent with the standards and ideals of Happy Canyon, which standards and ideals shall be determined in the sole discretion of the Happy Canyon or its Board of Directors, then you agree that the Happy Canyon may take such actions as it's sole discretion deems appropriate, including without limitation removing you as a Happy Canyon Princess. You understand and agree that if you are removed as a Happy Canyon Princess, you will lose all of the rights and privileges associated with that honor. You also agree to hold harmless Happy Canyon, and its Board of Directors, from any claims you may have as a result of removal, or other disciplinary action.
- 4. <u>Term of this Contract:</u> This Contract shall become effective on the date it is signed by Happy Canyon and by you, and shall remain in effect until you have performed all of your responsibilities and duties as a Happy Canyon Princess.
- 5. Happy Canyon Property. Happy Canyon will provide you with various costumes and apparel items for you to wear in performing your responsibilities and duties as a Happy Canyon Princess. These items remain the property of Happy Canyon during the term of this Contract. After you have performed all of your responsibilities and duties as a Happy Canyon Princess, these items are typically given to you as a souvenir of your time on the Happy Canyon Court. All Regalia, outfits, and apparel are **ONLY** to be worn to Happy Canyon functions during your time on the court. **Only Happy Canyon apparel** will be dry cleaned at no expense to you. Lost or damaged jewelry or clothing will be replaced at your expense if it does not occur at a Happy Canyon function. The Happy Canyon beaded bags remain the property of Happy Canyon and must be turned in when your responsibilities end in September. It is your responsibility to care for these bags while they are in your possession and must be returned in the condition they were received.
- 6. Hold Harmless Insurance. You understand and acknowledge that some of your responsibilities and duties may place you at risk of serious injury, or even death. You agree to save and hold harmless Happy Canyon, its Board of Directors, Officers, employees, agents and assigns, from any and all claims, losses, and liabilities of any kind arising from or connected with the performance of your responsibilities and duties, or with the subject matter of this Contract generally. You also agree to maintain a policy of health insurance during the term of this Contract.
