ORDINANCE 3225: AN ORDINANCE AMENDING ORDINANCE 3214 AS THE SECOND SUPPLEMENT TO THE 2021 ANNUAL APPROPRIATIONS AND DECLARING AN EMERGENCY. Was read for the first time.

RESOLUTION 3226: A RESOLUTION PROVIDING FOR A WAGE INCREASE FOR TWO EMPLOYEES OF THE VILLAGE OF LEIPSIC, PUTNAM COUNTY, OHIO; AND DECLARING AN EMERGENCY. Was read for the first time.

Marvin Maag discussed with council an option that could be added to Deferred Comp it is the Roth 457 Option. He told council he needed their approval to get it added and that it wouldn't cost the Village anything to add this. <u>CDBG Funding-</u> Marvin told council that there is CDBG funding that he would like the Village to apply for and he suggested that we use it on handicap parking space and parking around the pavilion at Bennett Park.

<u>House Rental-</u> Marvin Maag told council that he had someone come and fill out an application to rent the house. Mayor Tony Wobler asked how much do we charge to rent the house, Mr. Maag responded \$550.00 a month.

<u>Purchase of Mower-</u> Marvin Maag told council that in the budget for Parks/Streets we have a belly mower he said Leo went out and found one he wants to purchase it's going to cost about \$12,000.00. Al Pingle asked is that with a trade in, Mr. Maag responded no the guys were thinking to just keep the other mower it can be used for snow removal or even brought of to the pump station in Gilboa so a mower doesn't have to be trailed there every time they need to mow.
