#### Honours & Awards

#### **The Nobel Peace Prize Medal 1988**

In December 1988, the Norwegian Nobel Prize Committee awarded the Nobel Peace Prize to the *United Nations Peacekeeping Forces* for participation in numerous conflicts since 1956. All of those Canadian Peacekeepers who served from 1956 to 1988 are therefore *Nobel Laureates*. As of the time of the award, 736 people from a variety of nations had lost their lives in peacekeeping operations worldwide. The medal is distinct in design from other Nobel medals in that it is the only Norwegian medal, the others being of Swedish design. The original medal is kept at the *United Nations Headquarters* in New York.

The front side of the medal features a portrait of Alfred Nobel surrounded with the inscription of his birth and death in Latin: NAT-MDCCC XXXIII OB-MCCCC XCVI. '*Prix Nobel de la Paix 1988 Peace-Keeping Forces*' is engraved on the edge of the gold-cast medal.



#### **Reverse (Back)**

The other side of the medal represents a group of three men forming a fraternal bond. The Latin inscription reads '*Pro pace et fraternitate gentium*'(For the peace and fraternity of mankind). The Peace Prize Medal is of a different design from other medals.

# **VICE PRESIDENT'S ANNUAL REPORT 2006/2007**

#### GENERAL

In the absence of our President Tom Hoppe for unavoidable reasons, it is my honour to submit this report to the membership on his behalf – Tom and I have consulted about this report. The period of this report is from the Annual General Meeting 2006 to the present, a year which has been extremely eventful with the move of the National Headquarters from Victoria to Kingston. As well, the change of all of the elected Directors and a number of the key appointments has been a challenge to maintaining the flow of governance for our Association. Despite the changes, the past year has been very successful in terms of developmental changes which have been started and which are ongoing for the improvement of our organization.

The vision, articulated by our President, of an organization which will be a strong advocate and have a place for all veterans, bar none, and which will also offer an environment in which the younger veterans will be comfortable, has been and continues to be the direction for the future.

#### **REGIONAL DEVELOPMENT**

Our Association has been expanding with the founding of the new British Columbia Chapter in Victoria under the presidency of Harry Stinson and the inauguration of the Quebec Region with Karl Morel in the lead role. Discussions are also ongoing about a possible chapter in the Halifax area.

#### ADVOCACY AND REPRESENTATION

Prior to his departure, Tom Hoppe represented us in a number of meetings with Veterans Affairs Canada (VAC) and other organizations on advocacy issues particularly the New Veterans Charter (NVC). Following Larry Gollner stepping down as the Special Assignments Officer, our new person in that role, Marlowe Fraser, has represented us very well. I want to thank both Larry and Marlowe for the extremely valuable service they have given us. Marlowe continues to be our spokesman at the multilateral meetings on the NVC, the Gerontology Advisory Council and the NVC Advisory Group. CPVA has a very good reputation with VAC and other organizations as the result of the advocacy work by Tom, Larry and Marlowe. I was also asked to appear twice before the House Standing Committee on Veterans Affairs about the National Peacekeepers Day and about care and services to aging veterans – a very stressful experience which increased my respect for the very demanding work done by Tom, Larry and Marlowe. Dave Munro, our Past President, has also represented us at some meetings on issues which are a carry-over from his previous position: thank you Dave.

#### COMMUNICATIONS

Today's world demands effective and efficient communications. For that reason, the Board has appointed a Communications Officer, Karl Morel. As well, as a natural extension of his appointment, Karl has also accepted the position of the Editor of the Blue Beret. Karl has been doing outstanding work and I know we will see much more of the same from him – he is dedicated, hardworking and very talented. Rodd Kennedy, our Webmaster, has begun to streamline and update our website – we owe him a big thank you for his volunteer work. In the interest of more effective communications, I ask that everyone updates the National Headquarters with contact information for key positions and members: it is extremely crucial as we are becoming more internet focussed.

#### NATIONAL PEACEKEEPERS DAY

Although not yet enacted as law, the national Peacekeepers Day will be a reality very shortly. It was probably one of the few times that all of the political parties and the many veterans organizations at a meeting of the House Standing Committee on Veterans Affairs agreed unanimously. The Peacekeepers Day will be observed on 9 August or the closest weekend as decided locally. It should be noted that the day is primarily to give recognition to peacekeepers and the service they provide for Canada and the world, however, fallen peacekeepers will be remembered as well.

#### NAME CHANGE

Despite a hastener letter, we have not had any response from the Chief of Defence Staff or the Minister of National Defence about our proposed name change. I want to point out very clearly that if the name change is finalized, the Chapters will have the right to continue to use CPVA in their name and the name CPVA will be preserved in our Constitution.

#### THE ANNUAL GENERAL MEETING 2007

The first ever CPVA Annual General Meeting (AGM) by conference call will take place on 25 August 2007 at 1500 hrs EDT. It will provide a truly national forum and will overcome the representational problems inherent in a physical AGM where experience has shown that only the local people participate in the decision making. There will be some challenges with the AGM but with cooperation we will work our way to productive results for the good of CPVA. The convocation instructions and agenda are included in this Blue Beret. Other meeting documents have been sent and more will be sent prior to the AGM.

#### CONCLUSION

CPVA is a sound, solid, democratic organization and during the past year the Association has set a course for a bright and expanding future. Thank you all very much for your work, effort and cooperation in growing, developing and improving our organization.

## **MIRAMICHI CHAPTER NEWS**

Spring and Summer 2007

**MIRAMICHI, NB:** On 17 January 2007, Miramichi Chapter held its Annual General Meeting and elected a new Executive for 2007 and 2008, as follows: President Jim Muck, Vice President Ray Kokkonen, Secretary Ed Oursien, Treasurer Roy Matheson, Membership Terry McKay, Entertainment Leo Leblanc and Past President Dean Lawrence. A meal followed the meeting allowing for a time of fellowship.

On 11 April 2007, MCpl Allan Stewart, a member of the Royal Canadian Dragoons who was born and raised in the Miramichi area, was one of six Canadian soldiers killed in Afghanistan during the Easter period. A memorial service was held on 24 April 2007 in CFB Gagetown in honour of the six fallen soldiers and many members from the Chapter attended the ceremony. As MCpl Stewart's funeral and interment were held in Ontario, the people of the Miramichi had no opportunity to pay their respects to one of their own that had fallen in battle and therefore, at the request of the family, the Miramichi Chapter coordinated an ecumenical service held on 11 May 2007 in Miramichi, NB. Over eight hundred people were in attendance to pay their respects and say farewell to this fallen hero.

In May 2007, members from the Chapter attended the annual parades for the Air and Army Cadets in Miramichi, which has become a yearly tradition with this Chapter. As well, members from the Chapter attended the Wall dedication in at the Bathurst Legion in honour of CWO Robert Gerouard, killed in Afghanistan.

# **INAUGURATION OF CPVA QUÉBEC REGION**



**Montreal**, **QC**. With the anticipated confirmation by the Annual General Meeting (AGM) of the *Canadian Peacekeeping Veterans Association* (CPVA) to be held on the 25<sup>th</sup> of August 2007, I am honoured to have been chosen to serve as the Regional Chair for the CPVA in Québec. Privileged by this appointment, I have accepted the task to regroup our veterans in Québec into the CPVA and to help build the CPVA vision for the future.

The establishment of Québec Region will present some special challenges not met in other regions of the country. Nevertheless, the recruiting base is fairly large. For example, 63% of former peacekeepers come from Québec. The Montreal region provides the majority of Canadian police and peace officers for MINUSTAH, the francophone UN mission in Haiti. Moreover, French-Canadians are now serving in Afghanistan and will do so in increasing numbers as the next rotations are sent forth from Québec to wage war against terrorism.

If CPVA is to grow stronger as it evolves and goes forward into the twenty-first century realties of Canadian civil and military society, as it adjusts for the infusion of new veterans, it is vital for our recognition as a legitimate veteran's association to represent the entire country. The inclusion of the Québec Region will give CPVA added leverage with Veterans Affairs Canada (VAC) as well as with other veteran's service organisations nationally.

I therefore wish to solicit your support for the inauguration of the CPVA Québec Region, its Charter to be retroactive to the 9<sup>th</sup> of August 2007, soon to legally become our National Peacekeepers Day. I look forward to working with CPVA members across Canada as well as with the representatives of other veterans' organisations in Québec.

## May 29th

## INTERNATIONAL DAY OF UNITED NATIONS PEACEKEEPERS

The United Nations General Assembly has declared in favour of an *International Peacekeepers' Day* to pay tribute to all the men and women who have served and continue to serve in United Nations peacekeeping operations for their high level of professionalism, dedication and courage, and to honour the memory of those who have lost their lives in the cause of peace.

## **August 9th**

#### NATIONAL PEACEKEEPERS' DAY

The National Peacekeepers Day Bill C-287 was proposed to recognize the service of Canadians in the service of peace. It is meant to recognize Canadian Peacekeepers; past, present and future. Officially adopted by several provinces and many municipalities across Canada, August 9th was chosen because it was on that date in 1974 that the greatest single loss of Canadian lives on a peacekeeping mission occurred. National *Peacekeepers Day* in Canada is about commemoration and recognition of Canadian peacekeepers; thanks to those who help make the peacekeeping duty less arduous; and remembering those who have made the ultimate sacrifice in the service of peace.

# **PAST PRESIDENT'S REPORT**

Hopefully you are enjoying your summer; these are stressful days for those serving members and their families. Every day we see the news from Afghanistan. We are very proud of our troops who are serving there. We are always mindful of the Families who wait for their safe return. What we do not see or hear about are those that are serving at home or abroad in other countries and at sea. They and their families also deserve our prayers and thanks.

I had the opportunity from June 9<sup>th</sup>. to the 14<sup>th</sup>. to attend the B.C. Yukon Command Royal Canadian Legion convention in Victoria on behalf of CPVA and CAVUNP, specifically for our B.C. chapters and members. The theme of my address to the convention was to continue to expand our relationship with B.C. Yukon Command. Many CPVA and CAVUNP members in B.C. are also active members of B.C Yukon Command. As an example, the Victoria Chapter of CPVA Treasurer, Frank Chevrier, was selected the best Sergeant-at-Arms for the convention .Joan Chevrier, worked the electronics to ensure all speeches, resolutions and day to day business of the convention was recorded to be transcribed at a latter date.

The Legion needs to increase its ordinary members - those who have served in the military and RCMP. My address identified some of the changes that should occur as a starting point within B.C Yukon Command. If these changes occurred it may be possible to have our chapters and members to have a Legion leadership role and still maintain our Associations. An example of this type of organization would be the Legions T.B. Vets Branch. To further review and explore this possibility the B.C. Yukon Command First Vice President Cde. Dave Sinclair asked me to sit on his Futures Committee. Dave Sinclair has been one of the key people who have ensured a good working relationship in the past few years between B.C. Yukon Command and CPVA, CAVUNP .I will also be the South Vancouver Island Zone Service Officer & Seniors and Veterans chair. I have accepted these appointments. I believe working together will make both organizations stronger.

We in Victoria have a 14 unit housing project underway with a developer Mr. Russ Riddle his brother and the city of Colwood. These will be high quality affordable individual rental units available for veterans and their spouses. This will be a pilot project that we hope to showcase in the Western Region of V.A.C to start and then go National. Any bona fide veterans' organization may become involved in the administration of these rental units. More to follow in the next news letter.

We received an e-mail from Rights Management inquiring if CPVA is still interested in working with Rights Management they have been awarded the National contract from VAC for a Job Placement Program. I have e-mailed the firm that CPVA is interested and willing to be involved at all locations throughout the nation. (Note: This is subject to final approval by CPVA)

## CANADIAN PEACEKEEPING VETERANS ASSOCIATION ANNUAL GENERAL MEETING 2007 – BY CONFERENCE CALL 1500 hrs EDT, 25 August 2007

## **CONVOCATION INSTRUCTION**

#### GENERAL

As advised on 8 March 2007, the national CPVA Annual General Meeting 2007 will be held by conference call at 1500 hrs EDT, 25 August 2007. In preparation, the draft agenda was sent out for review and comments on 20 June with the outline of the meeting procedures. This now is the instruction and final agenda (attached) for the AGM. The meeting is expected to last approximately two hours.

#### PARTICIPATION AND REPRESENTATION

As it would be unreasonable to attempt to hold a conference call with every member participating directly, the membership will be represented by the Chapter Presidents (or Chapter designated representative) and the national Membership Chair. The procedure is intended to be that the Chapter Presidents will carry the votes of the Chapter members, either by specific vote on each issue or as a block proxy, as decided by each Chapter. It is also recommended that Chapters selects scrutinizers to be present with the Presidents for the conference call so that the Presidents are protected from possible future allegations of wrongdoing in relation to the AGM. The votes of members who are direct national members will be carried and cast by the national Membership Chair, as directed by each national member who will be contacted prior to the AGM to seek their decision on each issue. The elected members of the CPVA Board will participate in the conference call and the meeting will be chaired by the CPVA President, Tom Hoppe.

#### AGM DOCUMENTS AND BACKGROUND INFORMATION

The necessary reports and background information for the AGM, such as the By-Law amendment motions, will be sent to each Chapter and national member in sufficient time for review prior to the AGM. It is expected that the Chapters will meet to discuss and to determine how they will vote about various matters and to give direction to the Chapter Presidents.

#### VOTING ON BUSINESS ITEMS AND ELECTIONS

The number of paid up members for each Chapter and the numbers of direct national members will be verified and announced at the beginning of the meeting. The Chapter Presidents may cast votes up to the number of paid members the Chapter has, in any configuration of votes: for, against or abstain. The same applies to the Membership Chair for casting the votes of the national members. For elections, the Chapter Presidents and the Membership Chair will declare the number of votes for each candidate to the maximum number of their members – this ensures a secret ballot. Additionally, the elected members of the Board participating in the call will be an allowed a vote on each issue and the election, however, the CPVA President will not be allowed to vote except in the case of a tie vote.

#### CALL-IN INSTRUCTIONS FOR THE CONFERENCE CALL AND COSTS

The numbers for dialling into the conference call will be sent later to registered representatives. CPVA National HQ will bear the costs for the conference call arrangements and Chapters are expected to pay for their own long distance charges for the call.

#### REGISTRATION

Chapters are requested to register their one designated representative no later than 20 August 2007.to the National Secretary, Jeff Willis, jwillis2@cogeco.ca, telephone (613) 545-1425.

#### CONCLUSION

The foregoing arrangement will provide an effective, genuinely democratic process and representation of each member nationally, and will address the problem of national decisions being made locally where the AGM is held. Clearly, it will also allow national participation at the lowest possible cost.
