In order to qualify, applicant must have all of the following:

1. All applicants 18 years of age and older must fill out an application.
2. 6 months income verification (must be 2 times the rent amount.) Acceptable forms of verification are: Computer generated check stubs, bank statements, fax from employer, and verbal verification from payroll department. No other forms of verification will be accepted.
3. Good rental history from previous landlord.
4. Good credit report. Any unpaid collections may result in decline.

After reviewing rental application, Herring & Associates may elect to offer a co-signer. However, we reserve the right to decline an applicant without offering a co-signer based on information gathered from rental application. All applications must be processed and evaluated prior to a co-signer application being offered.

PET POLICY GUIDELINES

Herring & Associates maintains the request of the property owners whether or not to allow pets in a residence. Residences that allow pets will be indicated on the "For Rent" sheet.

1. There is a \$500.00 NON-REFUNDABLE pet fee and an additional fee for each additional pet varies per unit. This fee must be paid at the time the pet comes into the residence.
2. Pitbulls, Rottweillers, Doberman Pinchers and any mix of these breeds are not allowed.
3. There is a 25lb. maximum weight limit is allowed for pets (as adult).
4. No Birds or Ferrets are allowed on any of our properties.
5. If you have a service animal then you must provide certified documentation and must be submitted with this application.
