#### **RULES & REGULATIONS**

- 1. Each team will be comprised of TWO (2) Divers ONLY, NO EXCEPTIONS. No spectators or friends allowed.
- 2. Divers must be checked-in at Kona Brewing Co. by <u>6:30 am</u>, <u>with their partner</u>. No partner, no check-in. There will be a "rules & regulations" briefing and a Roll-Call completed by 7:00am.
- 3. All divers must return and check-in <u>with their partner</u> at Kona Brewing Co. by <u>1:00pm</u> or be disqualified. <u>BOTH PARTNERS MUST CHECK-IN</u>, <u>EVEN IF YOU DIDN'T CATCH ANYTHING!</u> Your partner <u>MUST BE WITH YOU</u> when you check-in.

\*\*IMPORTANT: If you will be late to the check-in, you MUST call in to 383-3374 to confirm that you are out of the water and on your way to Kona Brewing Company to check-in. If you cannot comply with this simple rule, YOU WILL FOREFEIT YOUR RIGHT TO ANY FUTURE PARTICIPATION IN THIS TOURNAMENT.

- 4. Mandatory Equipment:
  - a. At least one (1) Dive Knife per diver.
  - b. At least one (1) Cellular Phone per team.
  - c. Only <u>one (1)</u> Dive Float w/ Flag per 2-diver team will be allowed. This is to stress the "One-up, One-down Rule" for your safety.
- 5. Both divers must stay within a 50-foot radius of the team dive flag at all times.
- 6. No belt kuis will be allowed on divers. (Kuis will be allowed on team dive float only!)
- 7. Bag limit of <u>6</u> fish per team. The team's two largest fish will be weighed. Individual efforts only; no gang-banging or intentionally mutilated fish. Each team will be responsible for their own coolers & ice for their catch—we will not be taking donations of fish this year. Shooting any species NOT on the eligible list will result in disqualification.
- 8. Taxed fish NO taxed or mutilated fish will be accepted at the weigh-in.
- 9. All divers must enter, dive, and exit the ocean within the tournament boundaries. You must declare your dive area at the morning check-in.
- 10. All knives must be removed from knife fish prior to checking-in.
- 11. Absolutely NO drinking of any alcoholic beverages and beer allowed in the parking lot. Also, please do not bring your beverages into the event venue. Refreshments can be purchased in the restaurant.
- 12. It is the responsibility of each competitor to know & understand the tournament rules prior to the start of the competition.
- 13. If a competitor feels the rules are not clear, it is the competitor's responsibility to ask the Tournament Director to clarify said rules at the morning Rules Briefing.
- 14. The Weigh Master will have the FINAL say in all disputes at the time of weigh-in regarding eligibility of fish, divers, & interpretation/enforcement of the tournament rules.
- 15. PLEASE CARPOOL if possible, as parking at the Koko Marina Center is very limited.

## **APPLICATION, WAIVER and RELEASE (PAGE-1)**

This agreement is made and entered into by the undersigned in favor of Maui Sporting Goods and its officers, owners and employees, the State of Hawaii, the City and County of Honolulu, all event coordinators and officials, all sponsors, advertisers, owners and lessors of premises used to conduct the event, their associates and affiliates, boat operators, if any and volunteers who take part in this event (collectively, "Releasees").

In consideration of being allowed to participate in this event, known as the MAUI SPORTING GOODS FALL SHOOTOUT (the "Event"). I, for myself, personal representatives, successors, assigns, heirs and next of kin, and for and on behalf of my diving partners) identified on the front side of this instrument:

- 1. Agree, acknowledge and understand that skin diving and spear fishing is an inherently dangerous sport, and I made a voluntary choice to participate in this Event despite the risks the sport presents.
- 2. Certify that I am over the age of 18 qualified, in good health and in proper physical condition, and possess the skill and experience necessary to participate in this Event, and understand that I will not be subject to supervision during the Event. I agree that, prior to participating, I will inspect the existing weather and ocean conditions and the equipment to be used and. if I believe anything is unsafe I will immediately inform Event officials of such condition(s) and refuse to participate further.
- 3. Acknowledge and understand that I will be engaging in activities that involve the risk of serious injury, including paralysis, permanent disfigurement, disability, dismemberment and death, and severe social and economic loss which might result not only from the actions, inactions, or negligence of myself, but also the actions, inactions, or negligence of others, or conditions of the ocean or environment which are beyond the control of any person and risks not known to anyone or not reasonably foreseeable at this time.
- 4. Assume voluntarily all the foregoing risks, both foreseen and unforeseen, and accept personal responsibility for damages following such injury described above.
- 5. Release, waive, discharge and covenant not to sue Releasees, their respective administrators, officers, directors, managers, members, agents, employees and representatives, from any and all liabilities, claims, damages, costs, or losses, to myself, my personal representatives, successors, assigns, heirs and next of kin. including death or damage to property, direct or indirect, present or future, known or unknown, arising out of or related to my participation in the Event, and including any injury received or compounded by negligent rescue operations or procedures of Releasees; and I further agree that if despite this agreement I or anyone on my behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY. SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any expenses, attorney s fees, damages, or costs which any may incur as the result of such claim.
- 6. Agree to follow all rules, regulations, conditions and terms as set forth by Event officials. I will not do anything to degrade, embarrass, or cause harm to myself or other participants of the Event, and agree to conduct myself in a civil and sportsmanlike manner before, during and after, and that any uncivil or unsportsmanlike conduct will be cause for immediate disqualification from the Event at the discretion of Event officials. I also hereby acknowledge that I have read and understand all of the rules, regulations and requirements for this dive competition and duly understand that any infraction of the rules, regulations or requirements will result in my disqualification from this dive competition. I also understand that if my team fails to call-in to the tournament director if we will be late to the specified afternoon check-in time of 1:00pm, that I hereby forfeit any right to future competition in this tournament. I understand and agree that the Weigh Master has the final say in any and all disputes at time of weigh-in regarding this tournament.
- 7. Understand that unless provided elsewhere herein, all entry' fees are non-transferable and non-refundable.
- 8. Give permission for the use of my name, voice and/or picture in any broadcast, telecast, photograph, advertising promotion or other account of this Event.

I have read this RELEASE, WAIVER. ASSUMPTION, AND INDEMNITY carefully and fully understand that I have given up substantial rights by signing it and have done so freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding shall continue in full force and effect.
