Rhonda's Reflections

Well, the weeks have now stretched into months; we aren't quite there yet, but we are close to reopening the sanctuary on July 5th. As has been affirmed in social media, the Church never closed – perhaps the building, but not the true Church, which is the people. We are still worshiping, serving, giving, and filling the needs of our souls and our communities. I, for one, am ready to move on from this quarantined time of reflection. I have learned to listen better (mostly), to spend time with others more intentionally, and to prioritize those things which beg for my attention and need that attention. Now I am ready for a change, how about you? That being said, we aren't reopening just yet, but we are moving ahead with finding new ways to live out the ministry of St. Paul's UCC. We are maintaining and enlarging our contact base through new followers on Facebook. As we move into the summer longing, expecting, and hoping for growth in our discipleship with Jesus, we will be studying Philippians for the next few weeks. Most scholars believe this book of joy, encouragement, and challenge was written at time when Paul was confined to a prison in Rome, his own type of Shelter-in-Place at the time. Despite the fact that Paul's freedom was restricted, he still looked for ways he could express his faith, sharing, caring, and witnessing to those around him as well as to those who were far away. This letter of Paul's is full of hope, rejoicing, and expectation. Paul did not let his situation paralyze his correspondence or curtail the opportunities for him to live out his faith. He took time to reflect on how his situation could bring him closer to God and how his response could continue to advance the gospel, chained or not. I think this is a great letter to peruse while our movements are restricted but our voice is not. I hope during this summer you will take time to read through the whole letter of Philippians and try to place yourself in

Paul’s position. Consider how Paul is responding to his situation and how you can respond in a way that speaks of your hope, joy, and peace. I am looking forward walking with you through this letter to the Philippians with Paul. Most important, I am looking forward to worshipping with you on July 5th when we gather in the sanctuary.

ELEVATOR UPDATE

CONSTRUCTION – Things are going pretty well. At this writing, the electrics/wiring are being installed. By the time you read this, the process of laying the brick should be underway. Because of a miscommunication, the elevator wasn't ordered on time. It is now scheduled to be delivered at the end of August and will take 2-3 weeks to be installed along with the interior finish work. Scheduled finish time is now the end of September. You may notice a down time in construction at the end of July due to the wait for the elevator delivery. I think we will really appreciate the decision we made to enclose the stairs leading into Heritage Hall. It's going to make traveling those stairs much safer, especially in the winter months.

FUNDRAISING – Money continues to trickle in - \$2688.00 in April and \$2552.00 in May. To date, we have raised 92% of the funds we need to complete the project!! We are SO close to our goal. We just have \$41,000.00 to raise. Although this still sounds like a lot on money – if each **household** in our congregation could donate just \$100.00 between now and the first of September, we would have all the money needed. That's just \$1.65 per day!! So, how can we make it happen?? By **CHANGING UP THE ELEVATOR!!!** Check your couch cushions, look under your car seats, go through your winter coat pockets – save all your loose change for the next 2 months whenever you make a purchase. Throw it in a bucket and see how much you accumulate in 60 days. You'll be surprised how it will add up. Also, our deadline to be entered in the raffle for the first ride on the new elevator will be September 1. A \$250.00 donation will earn you a ticket for the raffle. Details for our grand opening will be in the September Communicator.

A special shout out to our trustees, Greg Walter, Kyle Opperman, and Larry Kill, as well as Bill Nuss and Glenn Hadley – these 5 guys have gone **ABOVE** and beyond the call of duty in helping with this project. If you see them, please give them a big thank you for all the work they have done.

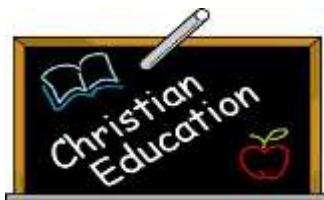

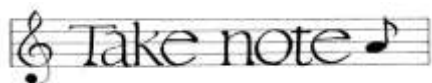

Also present were Pastor Rhonda Hainer, Treasurer, David Dickman, Custodian Bob Schumacher, and Administrative Assistant Carolyn Garrison. Guest Jeanette Tangeman.

Christian Ed & Nurture: Mary Holtzapple

- Held a meeting via Zoom on May 21st. Next meeting in July.
- Mary thanked Kara Birt and Julie Speckman for everything they have done for Christian Ed.

- We are going to be reviewing the old curriculum that is in the closet; however, we are also looking at some new.
- We are in need of a Sunday School Nursery Teacher, Superintendent and someone for the Café. We are in need of someone to be the CE&N Secretary. Sarah Walter has agreed to stay on as the CE&N Treasurer.
- A newsletter was sent to the parents and children with different church-based entertainment for the children.
- Rally Day is scheduled for August 23rd.

Minutes:

- Minutes from the May 13, 2020, meeting were reviewed. Lynda Hadley made a motion to approve the minutes. Kyle Opperman seconded. Motion carried.

Financial Report: David Dickman

- David stated that the Budget Report for the month of May 2020 is not ready yet due to Consistory meeting a week early. Carolyn will email the report out to everyone once it is ready.

President's Report: No report

Pastor's Report: Pastor Rhonda

- Pastor Rhonda thanked Jane Nuss for heading up the COVID-19 Committee which developed policies and procedures needed before we can restart worship in the sanctuary. This committee will be in charge of sanitizing and following policies regarding keeping our members safe.

Budget and Finance: David Dickman

- The payment from the Payment Protection Program has been helping. More people are giving online and we are now receiving approximately \$3,000 a month in online giving.

Elevator Committee: Lynda Hadley

- Construction is progressing. It is getting exciting. The elevator is expected to be delivered between August 7th and 14th. Expected completion is now September 30. Original completion date was August 28th. We will receive \$100 a day for each work day past the original completion date. Brick work is set to start next week. We have \$41,000 yet to raise to completely pay off the elevator.

Old Business: None

New Business:

- Jane Nuss reviewed the guidelines for opening the church (see Caring for Each Other attachment). We highly suggest that masks be worn, but we can't make you wear one. Those that don't wear one will need to sit in a designated section with others who do not wear one. We will continue to practice social distancing. A letter with the rules will be going out via email, regular mail and a Call-Em-All. The rules are in place to protect our members. Of the 206 email surveys sent out, we received 34 responses and 20 of those responding said that they would be willing to reserve their seat. We hope to open the church July 5th, but things could always change. Bulletins may or may not be provided and the screen will be utilized. Luke Leffel stated that currently, the Governor has Social Distancing expiring on July 1. This date could be subject to change. Kyle Opperman read the guidelines for social distancing. Luke Leffel made a motion to accept the Care for Each Other guidelines. Kyle Opperman seconded. Motion carried.
- Jeanette Tangeman requested guidance on starting Breaking Bread back up with maybe curbside service. Jeanette stated that she is torn with the need to feed and

to also keep them safe. Jeanette stated that she wants to keep in line with the guidelines of the church. Jeanette stated that she is “Safe Serve Certified”. After a brief discussion, we will re-evaluate this request again in July.
