A church member recently asked me what plans I might have for the next 1-5 years at St. Paul's United Church of Christ. My initial response was mostly a joke--survive the pandemic. It's difficult to make plans amidst so much uncertainty. When we don't know what next month will

bring, it's hard to even think of next year. We're living in a season of cancelled plans.

However, it occurred to me later on--we are not living in a season of cancelled purpose.

What plan do I have for St. Paul's UCC? The plan is to focus on our purpose:

- 1) We will continue to ground ourselves in scripture
- 2) We will continue to ground ourselves in prayer. We will pray for God's will to be done, and for our eyes to be opened to how God is calling us into the future.
- 3) We will continue our focus on mission, both through service and advocacy. Care for the world is in the DNA of the United Church of Christ denomination, and is crucial to moving forward.
- 4) We will use this time to better understand what is "essential" in the life of the church, and to consider our future accordingly.




