Maritime Psychology Clinic's Privacy Policy

Maritime Psychology Clinic is a Moncton area psychology practice. We recognize that the privacy and protection of personal information is important. Below, we outline the types of personal information we collect, how we use it, and how we protect it.

Information We Collect and How We Use It

Provision of Services

The main reason we collect personal information is to provide psychology services to our clients. We collect the personal information you (or, in some instances a colleague of yours, or legal guardian, or physician) provide to us. Your provision of personal information to Maritime Psychology Clinic means that you agree and consent that we may collect, use, and disclose your personal information in accordance with this privacy policy, and the laws within New Brunswick, Canada. Certain services can only be offered if you provide personal information. If you refuse to provide the necessary personal information, Maritime Psychology Clinic may not be able to offer you those services.

Your personal information that you may be asked to provide on this site may include:

Your name, mailing address, phone number, and/or e-mail address; your year of birth, gender, and language; and other personal information collected to provide a specific service to you.

Online Browser Data

We automatically collect technical data from visitors to our website. This data is not connected to your personal information. It includes:

- server logs, which permanently records your computer IP address, browser type, operating system, and timestamp for each webpage you visit;
- and session cookies, which temporarily stores on your computer your login information, the page you are viewing, and your language preference.

Access, Security, and Data Integrity

Access to your Personal Information

You have full access to the personal information we retain about you. We count on you to keep your personal information current. If any of your personal information changes, you can request that we update it on your behalf.

Protection of your Personal Information

We restrict access to the personal information we collect to employees and volunteers of Maritime Psychology Clinic. Maritime Psychology Clinic maintains a confidentiality policy to which employees and volunteers of Maritime Psychology Clinic are accountable.

We protect information using electronic, physical, and procedural safeguards.

We follow industry standards in protecting your information online. This includes:

- requiring login and password to view any personal information;
- encrypting personal information with SSL/HTTPS and security certificates;
- and maintaining firewall technology to block unauthorized access to our computers and information.

Storing of Personal Information

We store personal information permanently electronically, and on paper when necessary.

Our website server is located in Montreal, Quebec, Canada and our main offices and data servers are located in Moncton, New Brunswick, Canada.

Information Sharing and Disclosure

General

We do not give personal information to any third parties except as outlined below. You may opt-out of all services provided by third parties; however this will restrict the range of services available to you. We only provide third parties with the minimum information required to provide a given service. We do not give third parties the independent right to share your personal information with others.

Public

We do not disclose any information to the public regarding any client of Maritime Psychology Clinic. We may disclose certain information to other medical professionals only with your direct permission.

Government Requests and Legal Proceedings

We will provide personal information as is reasonably necessary to comply with applicable law, regulation, legal process, or enforceable government request.

Changes to This Policy

This privacy policy may be changed from time to time, as it represents our current practices. If any significant changes to the policy are implemented, we will notify our active members and affiliates.
