# **Terms Of Hire**

#### **Terms of Hire**

Contents of a bin or bins hired from Affordable Bins remains the property of the hirer until such time as the hirer pays Affordable Bins the full hire charge, if after a reasonable time the hirer has not paid Affordable Bins the full hire charge then the hirer agrees that Affordable Bins may empty the bin at the hirer's site, office or place of residence without further notice.

It is a basic condition of hire that no asbestos based materials or other hazardous material will be placed in a skip bin provided to a hirer by Affordable Bins. Unless prior arrangement.

If at the time of collection of a skip bin from the hirer's site or, when a skip bin is tipped out at Affordable Bins premises having been returned from the hirer's site the bin is found to contain any asbestos based materials or any other hazardous materials then Affordable Bins will charge the hirer for any and all costs of disposing of the contaminated contents of the bin and for any remedial services Affordable Bins has to undertake at it's premises which are attributable to having a bin returned by a hirer which contains asbestos based materials or other hazardous material.

The Customer will pay Affordable Bins on or prior to delivery of container unless otherwise arranged when ordering the bin.

In these Terms and Conditions, the following expression will, where the context admits, have the following meaning:

"Equipment" means the equipment described overleaf and all the containers used for the storage of waste material including stationary compaction units, stationary baling units, waste material loading device, tanks, tankers and such other on-site devices as may be specified on the face thereof.

"Customer" means the customer named overleaf. If the customer comprises more then one person, expression includes each of the jointly and severally.

"Service" means the service described overleaf.

### Customer's Obligations:

- 1. The equipment provided by the contractor is for the storage and collection of non-hazardous waste materials.
- 2. Customer shall be responsible for the cleanliness and safekeeping of the equipment.
- 3. Customer shall not overload the equipment, nor use it for incineration purposes, and shall be responsible for any loss or damage.
- 4. Customer warrants that the bin hired will not contain any hazardous or toxic waste as defined by applicable laws or regulations of the Commonwealth and States and Territories of Australia and that no free flowing liquids or viscous materials shall be deposited by the customer into the equipment.
- 5. No mechanical means will be used to compact the contents being placed in the equipment.
- 6. On collection day, the contractor's vehicle shall have access to the equipment. If the equipment is blocked to prohibit collection, customer will be notified and an additional attempt for collection shall be made by Contractor's vehicle. Any further attempts made for collection will be classified "extra service" and so duly charged.

## **CHARGES AND PAYMENTS:**

- 7. Payment shall be made by Customer to Affordable Bins on or prior to delivery via cash, cheque or credit card (visa, mastercard)(credit will incur a 1.8% fee). Payment can be made to the driver at the time of delivery, credit card over the phone or in person at our office at 158 Frederick Street, Welland (prior to delivery).
- 8. A surcharge of \$20 per mattress will apply when placed in any of our bins.
